Agenda Item: By-Laws

Presenter: Kathie Anderson, Gifted Program Consultant, Division of IDEA Implementation and Preschool, Kentucky Department of Education

Summary of Discussion:

Anderson presented information to the council on the current state of the by-laws (A marked up copy of the by-laws was presented on screen for the council to view during this portion of the meeting). The revisions of the by-laws started in November of 2017. The by-laws/ operational procedures of the council must align with the statutes.

The by-laws were reviewed in their entirety, with explanation provided for the proposed edits and/or deletions of items that were not aligned to the statute.

Question from the floor from Brenda Martin - Is there anything in policy that speaks to the weight given to the advice of the council?

Anderson provided a response that there is nothing outlined in policy, however, input from the council is considered very seriously. She went on to provide an example of a previous recommendation given related to technology regarding the Gifted Student Services Plan.

Council membership language was discussed, and it was noted that the by-laws must return to what the Kentucky Revised Statutes (KRS) states, not the previous executive order. Council members are appointed by the governor's office according to the statute.

Joe McCowan emphasized the term limit of two consecutive terms and members must be reappointed.

Question from the floor from Kirk Haynes regarding the numbering of the section items in the presented document.

McCowan provided a response that we will need to review the document numbering.

Feedback:

Phillip Kash asked if the edits were made available ahead of time. He went on to state it is irresponsible to not have time to think about the changes prior to voting.

McCowan responded that the edited by-laws would be sent to members for ample time to review and vote on them at the next meeting.

Brenda Martin asked what is the date of the previously approved by-laws?

Anderson responded November 2017.

Haynes asked if there is anything that requires a 1st and 2nd reading?

Anderson responded it is up to the operational procedures of the organization. There are no existing guidelines in this area.

Tiffany Marshall stated if the changes made were to align with the statute, she recommends the council move forward with the vote.

Kash stated that he can abstain his vote if the council moved forward.

- Motion made by Marshall for moving forward to vote with the updated by-laws
- Second by Martin
- Discussion on the motion
 - Martin stated a motion may be made later to review the newly appointed bylaws at another meeting.

Agenda Item: Review of Recommendations and Priority Setting

Presenter: Kathie Anderson, Gifted Program Consultant, Division of IDEA Implementation and Preschool, Kentucky Department of Education

Summary of Discussion:

Anderson led the council in a review of previous priorities of the council:

- Gifted Regulation;
- Excellence Gap
- Differentiation Strategies for Classroom Teachers;
- Visual and Performing Arts Services during Covid-19; and
- Social Emotional Needs of Gifted Students.

Council members used an electronic brainstorming tool called Padlet to present ideas for the priorities of the council. Members were instructed on how to use Padlet for the purposes of the priority setting activity.

The council had discussion about the ideas presented.

Several points of discussion focused on:

- Equity in identification
- Exposure
- Assessment and an accountability model in gifted education
- Biased testing leading to inequity
- Establishing a rubric for an equitable process for accountability

Julia Roberts referenced a blog from the Prichard Committee regarding numbers in the Commonwealth.

Anderson referenced a tool in Infinite Campus (IC) that can provide demographic Gifted and Talented (GT) data. Julia Roberts suggested combining the equity items into one united area of concern.

The top three priorities include:

- 1. Equity practices
- 2. Clarity on accommodations for GT identification and testing
- 3. Social and Emotional Learning (SEL) for GT students
- Motion made by Kirk Haynes to accept the council priorities
 - Second by Katie Booth
- Discussion on the motion by Jessica Greene on the item of equity and what that includes. She stated the danger of grouping everything under one umbrella of equity is that the specific items can get lost.
- Roll call vote. Reminder to turn on cameras during voting
