##### ***COMMENTS FROM WILLIAM "BILL" TWYMAN, KENTUCKY BOARD OF EDUCATION CHAIR***



As most of you know, the Kentucky Board of Education had a special meeting on November 28 to study and discuss charter schools, since a bill on this topic is likely to come out of the 2017 General Assembly. I am proud to say that the tone and atmosphere of this meeting was one where all members were gathering knowledge and facts about charter schools to see if this board could come to agreement around a possible policy initiative to include in its legislative agenda. At the end of the study session, Kentucky Department of Education (KDE) staff were asked to follow-up with some additional information for us to consider and to draft a proposal on charters for possible action on Dec. 7.

I am pleased to report that KDE quickly produced the follow-up information for us and also a document that was couched as presenting recommended best practices for charters to provide to the General Assembly if a bill comes forward for passage. While the board did not endorse charter schools, we did unanimously come together around the recommended best practices document. Members of varied opinions wholeheartedly agreed that we support initiatives that drive advances in student learning and minimize any negative effect on the public schools.

It was a proud moment to see that the Kentucky Board of Education is still and has always been about what is best for students.

##### ***BOARD APPROVED RECOMMENDED BEST PRACTICES FOR CHARTER SCHOOLS***

The Kentucky Board of Education approved at its December 7 meeting recommended best practices for charter schools to be included in its legislative agenda for the General Assembly to consider if a bill

comes forward for passage. It also was made clear that the board supports initiatives that drive advances in student learning and minimize any negative effects on the public schools.

### ***2017 LEGISLATIVE AGENDA APPROVED***

In addition to advancing the board's recommended best practices for charter schools, the Kentucky Board of Education approved that the Kentucky Department of Education's primary focus during the 2017 session would be on aligning Kentucky's accountability system with the new requirements in the Every Student Succeeds Act (ESSA). Two other issues are reflected on the legislative agenda: addressing the unfunded liability of the Teachers' Retirement System and Kentucky Retirement System and expanding career and technical education opportunities throughout the state.

### ***BOARD HEARS UPDATE ON STATUS OF NEW ACCOUNTABILITY SYSTEM***

Associate Commissioner Rhonda Sims brought the board up-to-date on where the development of the new accountability system stands. She noted that due to the U.S. Department of Education's extension of the timeline for submission of Kentucky's plan for the system to September 2017, the board would not be required to have a special meeting in January but instead would be getting details on the new system at its February meeting.

Sims shared the following schedule with the board:

- November 1 – Consequential Review Work Group held first meeting to begin looking at any unintended consequences from the recommendations of the Systems Integration Work Group.
- November 2 – Accountability Steering Committee meeting held to provide feedback to the Systems Integration Work Group on their recommendations.
- November 14 and 15 – Focus Groups were held with higher education and business and industry to secure additional feedback from these constituencies.
- November 15 – Regulatory Review Work Group held its first meeting to look at shaping regulations for the new accountability system.
- November 16 – Systems Integration Work Group met to consider feedback from the Accountability Steering Committee.
- November 30 and December 1 – (new meeting dates) Systems Integration Work Group to continue its work.
- December 6 – Discussion of accountability work with superintendents at the KASS Winter Conference.

*Note: From this point on, subsequent meeting dates are scheduled for January due to holidays and school breaks.*

- January 6 (rescheduled from November 21) – Consequential Review Work Group to continue its work on looking at unintended consequences from the recommendations made for the system.
- January 9 and 10 (rescheduled from November 30 and December 1) – Accountability Steering Committee to meet, look at feedback from the Systems Integration Work Group and finalize its recommendations on the new accountability system.
- Early February – Content of the new accountability system made available for public review and comment.

### ***K-SCREENER UPDATE PRESENTED***

Associate Commissioner Amanda Ellis reminded the board that this was the fourth year of the kindergarten screener administration to provide readiness results to schools and districts as soon as the screener is given. Thus, instruction can be based on these results and planned to meet children’s needs.

Though the results of the 2016 screener overall remained unchanged from last year showing about 50% of children ready for kindergarten, some encouraging trends have begun to emerge relative to continuous growth of African American students, those in state-funded preschools and those from Head Start.
