

Custom Report: Dual Credit Scholarship – The purpose of this report is to create a single file to submit to KHEAA for students who may be eligible to receive funding from the Dual Credit Scholarship and/or the Work Ready Scholarship. To receive funds, KHEAA requires the last four digits of the student’s social security number and full mailing address. Student email addresses are recommended to expedite scholarship processing. Courses must be set up per the [Dual Credit Data Standard](#) to be included in these reports.

The Dual Credit Scholarship Program is for 11<sup>th</sup> and 12<sup>th</sup> grade students taking dual credit courses. The Work Ready Scholarship is for 9<sup>th</sup> through 12<sup>th</sup> grade students taking Career and Technical Education dual credit courses.

NOTE: Given the personally identifiable data in this file, best practices for security must be applied.

**Step 1 - Error Report:** Open in Excel to view errors, then correct in IC.

- Run the report at the school level.

  - Please note the birthdate is in year/month/day format.

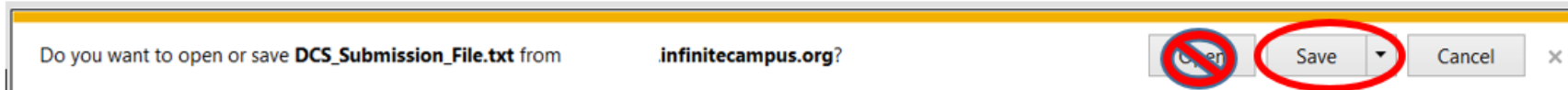
- Only Middle Initial, Zip plus 4, and Email Address may be blank.
- Providing an email address allows KHEAA to contact the student in a timely manner.
- Run the Error report until it returns no students before moving on to Step 2 - Validation Report.

**Step 2 - Validation Report:** Open in Excel to validate dual credit students.

- Complete Step 1 before running the Validation Report.
- This report provides a readable version of the Submission File.
- Run the report at the school level.
- Verify all 11<sup>th</sup> and 12<sup>th</sup> grade students taking dual credit courses through DCS participating institutions are included.

**Step 3 - Submission File:** Save in a secure location as a csv file, then upload to KHEAA.



- Run the Submission File for All Schools only after Steps 1 and 2 are completed.
- Save the file in a secure location for upload to KHEAA.
- DO NOT open the Submission File. This may corrupt the file formatting and the file will not properly upload to KHEAA.
- KHEAA allows uploads throughout the year and will ignore previously submitted students. To modify existing student information, contact KHEAA.
- Permanently delete the file once upload is complete.
