### School Report Card – Round 2 of the Data Review Window Starts today

The School Report Card (SRC) Data Approval Tool now includes Overview and Education Opportunity data for review and approval in addition to School Safety data that already was available.

Schools and districts can begin verification of this data, continue to enter school collection items through the collection tool, flag data issues and approve data within each of these domains. The review period for the School Safety domain was extended to **Aug. 7**, and the review period for the other domains ends on **Sept. 29**. In addition, all collection items should be entered by **Sept. 29**.

The [SRC Quality Assurance Worksheet](#) includes KDE contacts by data point if there are questions about the data.

As a reminder, there are data points within these domains that are not available at this time; details by SRC domain are provided below. As this data becomes available SRC contacts will be notified.

- Equity (expected early September)

#### Education Opportunity data points not yet available:

- Advanced Coursework /Numbers Tested and Students with Qualifying Scores: Cambridge Advanced International only
