# **Kentucky celebrates 103 New National Board Certified Teachers**



- Kentucky recognized 103 teachers newly certified by the National Board for Professional Teaching Standards (NBPTS) during a Feb. 8 ceremony.
- Kentucky has the 10th-largest class of new National Board Certified Teachers (NBCTs) in the country, and the Commonwealth now has 4,373 NBCTs overall. This year, 253 Kentucky educators opted to renew their certification.

#### **Competitive Grants from KDE**

#### FY24 Reading Diagnostic and Intervention Fund Mini-Grant

- Grant applications due: March 19 by 4 p.m. ET
- Award Amount: \$40,000
- Matching Funds Requirement: No

Funding to support K-3 students in reaching proficiency in reading and writing through the purchase of high-quality instructional materials aligned to the *Kentucky Academic Standards for Reading and Writing* 

#### FY24 Preschool Quality Partnership Grant

- Grant applications due: March 22 by 4 p.m. ET
- Award Amount: up to \$300,000
- Matching Funds Requirement: No

Funding to support full-day, high-quality early childhood services for 3and 4-year-old preschool children. The goal is to expand access to or enhance the quality of existing programs to meet the unique and unmet needs of children and families in communities across the state.



#### **Competitive Grants from KDE (continued)**

FY24 McKinney-Vento Homeless Children Education Program Grant

- Grant applications due: April 18 by 4 p.m. ET
- Award Amount: Varies
- Matching Funds Requirement: No

KDE's Office of Continuous Improvement and Support is issuing a Request for Applications from local educational agencies to develop and implement programs that facilitate the enrollment, attendance and success of homeless children and youth in school.

# 2024-2025 Commissioner's Student Advisory Council Applications Open



#### **USED Requires Optional Questions in FY23**

- U.S. Department of Education (USED) made all previously optional questions mandatory in the FY2023 report
- New questions include:
  - Expenditures by activity (in addition to previous questions covering expenditures by object code)
  - Staff FTE counts in select positions District-Wide
  - Staff FTE counts by School
  - Student Eligibility and Participation counts



#### American Recovery Plan (ARP) Liquidation Extension

The ARP ESSER Grant Period ends Sept. 30, 2024

#### **ARP ESSER Reminders**

- All ARP funds must be **obligated** no later than Sept. 30, 2024. Funds which are part of an ARP extended liquidation request must be obligated by July 1, 2024.
- Without an approved liquidation extension, all ARP ESSER payments must be paid and reimbursements requested by Nov. 15, 2024.
- With an approved liquidation extension, certain ARP ESSER payments and reimbursement requests can be extended for up to 18 months (to February 2026).

#### **ARP Liquidation Extension**

- The template is largely the same as was required for an ESSER II Liquidation Extension Request, with a few additional questions
- EXTENSIVE documentation is required to be submitted and maintained in KDE throughout the extended liquidation period
- KDE will collect District ARP Extension Liquidation Requests in GMAP
- Change Orders to ESSER-funded obligations that are signed after Sept. 30, 2024, cannot be paid with ESSER funds

### When Federal Funds are Obligated

If the obligation is for —	The obligation is made —	
(a) Acquisition of real or personal property	On the date on which the district makes a binding written commitment to acquire the property.	
(b) Services by an employee of the district	When the services are performed.	
(c) Services by a contractor who is not an employee of the district	On the date on which the district makes a binding written commitment to obtain the services.	
(d) Performance of work other than personal services	On the date on which the district makes a binding written commitment to obtain the work.	
(e) Public utility services	When the district receives the services.	
(f) Travel	When the travel is taken.	
(g) Rental of real or personal property	When the district uses the property.

# Other ARP Reminders – Construction and Renovation Projects Funded with ESSER Funds

- Davis Bacon Act compliance is required
- Prior Approval by KDE is required (including HB678 districts)

Buses/Vehicles	Buses, Cars, Vans, etc.	Chay Ritter (chay.ritter@education.ky.gov)

# Statewide Literacy Coaching Model Launch

#### Read to Succeed Act, SB 9 (2022)

Per <u>KRS 158.305</u>(10), by Sept. 1, 2023, if funds are appropriated, the department shall establish required teacher academies or coaching models for teachers of students in prekindergarten through grade 3. The teacher academies or coaching models shall be related to evidence-based practices in instruction, instructional materials and assessment in reading.

Funded via the Read to Succeed Fund, per KRS 158.806.





#### Division of Early Literacy (DEL) Team Structure

- Director, Christie Biggerstaff
- Assistant Director, Ashley Hill
- 5 State Regional Literacy Directors (field staff)
- 25 State Literacy Coaching Specialists (school-based field staff)
  - To be placed in schools with "greatest need"



#### **Literacy Coach Responsibilities**

The school-based literacy coach will partner with schools to:

- Build relationships with leaders and teachers at the school and district level;
- Provide on-site coaching Monday-Thursday of each week;
- Assess the current state of literacy instruction within the school;
- Observe instruction and provide constructive feedback and opportunities for reflection;
- Create plans, goals and action items to address and monitor areas of literacy improvement through regular coaching cycles;
- Support teachers in unit and lesson internalization for the school's adopted high-quality comprehensive reading program, per KRS 158.305;
- Co-teach with and/or model lessons for teachers;
- Lead professional learning communities or communities of practice focused on instructional preparation while building leadership capacity;
- Lead data conversations; and
- Facilitate small group or schoolwide professional learning opportunities.





#### **School Partnership Considerations**

#### Filter 1: Performance Considerations

- First, schools with 50% or more students identified as "novice" as measured by the Kentucky Summative Assessment Grade 3, Reading.
- Next, schools with 40% or less students identified as "proficient" and "distinguished" as measured by the Kentucky Summative Assessment Grade 3, Reading.

#### Filter 2: Instructional Considerations\*

- Schools implementing high-quality instructional resources for early literacy, as required by KRS 158.305.
- Schools utilizing KDE approved valid and reliable universal screeners and reading diagnostic assessments, per KRS 158.305.

#### Filter 3 – Non-Academic Considerations

- · State Literacy Coaching Specialists (SLCS) placement will represent all geographic regions.
- · SLCSs will not be placed within their home school.
- School leaders commit to key assurances as outlined by the KDE.



#### **Communication Timeline**

- Superintendents Webcast, Feb. 13
- Following the webcast, email sent to superintendent and building principal with language inviting them to an informational webinar
- Informational Webinar Feb. 27
- Assurances sent to district and school administrators to be reviewed and signed
- DEL team will meet with the LEA on-site to walk them through the assurances and the vision for the partnership.
- Goal: School-based literacy coaches begin learning about their partner school this spring and attend any HQIR-related professional development over the summer with school staff.

## **Legislative Update**

#### 2024 Regular Session

#### **General Schedule**

- The 2024 regular session began on Jan. 2;
- Last day for new House bills is Feb. 26, for the Senate, Feb. 28;
- The veto recess is March 29 through April 9;
- The final two legislative days (#29 & 30) are April 12 and 15 (sine die).
- Regular Session Calendar

#### Committees

- Education Committees and Appropriations and Revenue Committees are of the most interest
- All are streamed live via the KET (Kentucky Educational Television) feed or LRC's YouTube channel.
- <u>Full committee schedule</u>

#### **Budget Process**

- Governor's proposal is HB 114
- House's is HB 6
- Governor has line-item veto power in the budget bill
  - Which can be overridden with a simple majority vote in each chamber.



#### **Senate Bills of Interest**

- SB 8: Kentucky Board of Education elected instead of appointed
- SB 11: Amends KRS 610.345 to require notice to schools prior to filing of a public offense petition against a child in certain cases
  - Reported favorably; in the Regular Orders of the Day for Tuesday, Feb. 13
- SB 18: Changes to school bus specs
  - Passed 38-0; has not been assigned in the House
- SB 38: Free feminine hygiene products for elementary and secondary students
- SB 40: Kentucky Proud School Match Program
- SB 52: Artificial intelligence in education
- SB 66: concealed deadly weapons
- SB 93: Diversity, equity, inclusion and belonging



#### **Senate Bills (continued)**

- SB 92: Transportation of students via passenger vehicles
- SB 95: Requires public schools to provide reasonable accommodations to a lactating student
- SB 114: Modifies the types of school facilities where weapons are prohibited
- SB 120: Prohibits a public agency from using public funds for lobbying activity or to employ or enter into a contract with a lobbyist
- SB 135: Vaccine requirements
- SB 165: Removes requirements for using a Social Security number as an identifier
- SB 169: Establishes a process to recall a member of a local board of education
- SB 170: Local boards of education membership
- SB 171: Removal of a superintendent by a local board
- SB 192: CTE funding distribution



#### **House Bills**

- HB 2: Constitutional amendment on education funding
- HB 22: Removes the requirement for medical oversight of an automated external defibrillators (AED) program
  - Passed House 87-0; assigned to Senate Education
- HB 96: Moment of silence and reflection at the start of the school day
  - Passed House 79-17; not assigned in Senate
- HB 119: Allows participation in a public school interscholastic extracurricular activity by an at-home private school student
- HB 162: Numeracy
- HB 208: Constitutional amendment related to school funding
- HB 225: Education clean-up bill
- HB 227: Provides a merger process for contiguous school districts
- HB 245: Removes expected family income from the selection criteria for the teacher scholarship
- HB 275: Teacher misconduct
  - Passed House 95-0; has not been assigned in Senate



#### **House Bills (continued)**

- HB 300: Process and procedures for receiving and processing a complaint against a certificate holder
- HB 304: Parental rights
- HB 346: Requires a school district to adopt health curricula that includes human growth and development instruction that meets specific criteria
- HB 377: Teacher recruitment and retention
  - Reported favorably
- HB 387: Substitute teacher certification
  - Reported favorably
- HB 446: Requires local school boards to adopt a transportation services policy
- HB 447: Transportation via passenger vehicles
- HB 464: Codifies HB 678 (2022)
- HB 471: Allows the use of military orders as proof of residency for enrollment or course registration in a school and prohibit in-person enrollment or course registration when prevented due to official military duties
- HB 499: CTE funding distribution



#### **Resolutions of Interest**

- HCR 43: Reestablishes the Early Childhood Education Task Force.
  - Findings and recommendations due to LRC by Dec 1, 2024
- HCR 51: Autism in Education Task Force; directs the task force to study autism supports and services provided to K-12 students by Kentucky public schools.
- HCR 60: Support Education Excellence in Kentucky (SEEK) Task Force.
  - Findings due to LRC by Dec 1, 2024.

# School-Based Services Survey



## Purpose

- Determine the services currently provided in school districts
- Identify areas of need
- Gain a better understanding of how services are being delivered in Kentucky's schools.
- Identify where DMS and KDE may need to provide additional training.
- Where resources should be allocated.



## Our Goal

**ALL** school districts enrolled in school-based services



### Stats

School Districts - 171
School-Based Services - 168
Expanded Access/Free Care - 58
Not participating or have not been approved - 3

(One of these districts is considering billing they currently participate in SBAC but not in Direct billing)



#### National Alliance on Mental Illness – NAMI

- 1 out of 6 U.S. youth aged 6-17 experience a mental health disorder each year.
- ½ of all mental health conditions begin by age 14.
- Children spend much of their productive time in educational settings,
- Schools offer a unique opportunity for early identification, prevention and interventions that serve students where they already are.
- In 2019, <u>15% of adolescents aged 12-17</u> reported receiving mental health services at school.
