Kentucky school districts recognized for meeting college, career goals

 KENTUCKY SCHOOL DISTRICTS RECOGNIZED FOR MEETING COLLEGE, CAREER GOALS

(FRANKFORT, Ky.) – Education Commissioner Stephen Pruitt recently recognized 111 Kentucky public school districts for making good on a pledge they made five years ago to improve the college- and career-readiness of their high school graduates by 2015.

All of the state’s 169 P-12 school district superintendents and local board of education chairs signed the pledge – known as the Commonwealth Commitment to College and Career Readiness – in 2011. (In Kentucky, five public school districts do not have high schools). Each of the districts had a unique goal to reach based on increasing its 2010 college- and career-readiness rate by 50 percent by 2015.

“Through hard work and dedication to their students’ needs and futures, the majority of Kentucky’s public schools met the commitment they signed in 2011,” said Pruitt, who recognized districts that met their goals at the Kentucky School Boards Association conference in Louisville on Feb. 27.

Infinite Campus Intervention Tab

If you're an administrator at a third- or fourth year Focus school, hopefully you had a chance to review your Intervention Tab feedback from the January submission and make revisions in time for the March submission deadline. Why is Intervention Tab so important? The Intervention Tab collects data about intervention services provided to students and their outcomes. Appropriately planned interventions help more students reach college readiness benchmarks, increasing college and career readiness rates. Schools can use the Intervention Tab to track student-level interventions and the results of the interventions.

Student intervention plans in the Intervention Tab in Infinite Campus are required to be entered for the following students:

- All high school seniors who did not meet statewide ACT benchmarks on the junior year administration
- All extended school services (ESS) students
- All third-year Focus schools for their students scoring Novice
- All students served by Read to Achieve grants
- All students served by Mathematics Achievement Fund grants

Districts and schools may enter intervention plans in Infinite Campus for other students, but they MUST provide them for the students who fit the descriptors above. If those interventions are being provided in the regular classroom, they are still intervention services, and would need to be recorded in the Intervention Tab. Student intervention records should be entered when a child is identified for interventions, and the record would be updated at least monthly. Student records should be entered before Oct. 30, Jan. 30, March 30 and June 30, since the state will access the data for review on those dates. End of year records should be completed by June 30 and final service results and end dates should be entered for students. The data collected from Intervention Tab eventually will be used to provide best practice data to schools and districts on the success of intervention programming and overall student improvement data to the Kentucky Board of Education and relevant shareholders.

Comprehensive School Improvement Plans (CSIPs)

The Office of Next Generation Schools and Districts is reviewing Comprehensive School Improvement Plans (CSIPs) for new Focus Schools and providing feedback on the plans to assist schools with improvement planning. The goal is to help ensure plans are developed and implemented effectively. This review process by the department is not to be viewed as a "gotcha" but as a technical assistance measure. In April, principals of newly-designated Focus Schools identified from the 2014-2015 School Report Card data will receive feedback that includes plus/delta, a quality tool used to identify strengths as well as opportunities for

improvement.

Section 8(1) of KAR 5:225 states that the Department of Education shall review and approve all submissions of Comprehensive School and District Improvement Plans completed in ASSIST.

The department shall monitor implementation and shall provide guidance based on the review of the plans by a person designated by the department and assigned to such school or district.

 - What is there cause to celebrate?
 - What is the need for improvement?
 - What are our next steps?

LEAD-Kentucky- National Institute for School Leadership (NISL)

KDE has been working with the National Institute for School Leadership (NISL) to provide leadership training to school and district leaders. NISL is a thoroughly researched and fully tested program designed to assist schools and districts across the state with leadership development efforts.

The intent is to build leadership capacity through distributed leadership, increase recruitment and retention of effective leaders and improve student achievement.

The 12- to 13-month NISL Executive Development for School Leadership curriculum focuses on:

- training in standards-based instructional systems aligned by KDE and NISL staff,
- training in data analysis skills related to

student achievement data,

- capacity to take learning theory into practice, by providing skills and knowledge to enable principals to be instructional leaders in literacy, math, and science in their own schools, and
- training principals in distributed leadership strategies that will assist in developing the professional capacity of school staff.
