## **MONTICELLO INDEPENDENT WAIVES RIGHT TO HEARING; STATE BOARD MEETS TO CONSIDER STATE MANAGEMENT**

(FRANKFORT, Ky.) – The Monticello Independent school district has waived its right to an administrative hearing per KRS Chapter 13B before the Kentucky Board of Education to consider an appeal of state management of the district. The hearing was scheduled for 2 p.m. ET, Wednesday, February 20.

In lieu of the hearing, there will be a special meeting of the Kentucky Board of Education at that time to consider commissioner Terry Holliday's recommendation for state management (pursuant to [KRS 158.780](#), [158.785](#) and [703 KAR 3:205](#)) of the Monticello Independent school district. The meeting will be held in the State Board Room, First Floor, Capital Plaza Tower in Frankfort.
