

SUPERINTENDENT'S CONTRACT
CONTRACT FOR SECRETARY OF BOARD OF EDUCATION
[BOARD POLICY 02.1311]

**COMMONWEALTH OF KENTUCKY
COUNTY OF LIVINGSTON
SMITHLAND, KENTUCKY 42081**

This "Article of Agreement" made and entered into this the 8th day of July, 2013, to wit:

WITNESSETH: That William Darryl Chittenden of 108 Montevista Drive, Salem, Kentucky 42078, holding a certificate in administration and supervision, as provided by KRS 160 et seq and as recorded below, hereby contracts with the Livingston County Board of Education of Smithland, Kentucky, as Superintendent of Schools of said District for an **additional term of FOUR (4) years beginning on the 1st day of July, 2014**, in accordance with the Kentucky Revised Statutes, the Common School Law and the Rules and Regulations prescribed pursuant thereof by the State Board of Education. **NOTE:** Specific reliance is placed on Board Policy #02.1311 as provided to and adopted in its entirety by the Livingston County Board of Education as given by the State Board of Education.

IT IS AGREED that William Darryl Chittenden shall receive an annual salary of **ONE HUNDRED AND ONE THOUSAND (\$101,000.00) DOLLARS** per year, with raises to be given annually at an equal percentage to those given other certified personnel [**NOTE:** any referenced raise given prior to the effective date of this pay rate **shall** apply to the annual salary noted herein], to be paid in regular monthly installments out of the school fund of said District. Said District shall pay all professional dues during the life of this Agreement to KASS and KASA.

IT IS FURTHER AGREED that Superintendent's work year shall consist of not less than Two Hundred and Forty (240) days and that Superintendent is to devote his entire time to the discharge of his duties as set out by law, rules and regulations of the Commonwealth of Kentucky and the State Board of Education and the Livingston County Board of Education, and that failure to do so will invalidate this Agreement.

IT IS FURTHER NOTED that the overriding reasons for the raise in the base Salary are (1) the fact that Superintendent accepted an unadjusted base rate at the time of his Original Agreement, and (2) the fact that Superintendent's work has been exemplary up to this point.


The Certificate for William Darryl Chittenden for certification as a School Superintendent is No. XXX-XX-4063 issued on 12-12-2009 and continuing.

The said District further contracts with William Darryl Chittenden to serve as Secretary of said District Board of Education for a period of FOUR (4) years beginning on July 1, 2014, and expiring on June 30, 2018, as is authorized by KRS 160.440. It is agreed there shall be no additional compensation other than the above-stated and further Superintendent shall perform his duties in the same manner as heretofore stated.


This Contract is conditioned on the fact that Superintendent has no criminal record.


