ADDENDUM TO CONTRACT
EMPLOYING SUPERINTENDENT

This ADDENDUM TO CONTRACTUAL AGREEMENT EMPLOYING SUPERINTENDENT made and entered into this 2nd day of December, 2012, by and between the Board of Education of Rowan County ("BOARD"), and MARVIN MOORE, ("SUPERINTENDENT"), as authorized at a duly conducted meeting of the BOARD on November 20, 2012,

WITNESSETH:

WHEREAS, by CONTRACTUAL AGREEMENT entered into on the 16th day of June, 2009, Marvin Moore was re-appointed and employed as the Superintendent of the Rowan County Schools for a period beginning on the 1st day of June, 2009, and expiring on June 30, 2013; and

WHEREAS, the BOARD at its June 12, 2012, meeting, by motion and sufficient votes, timely exercised the provisions of KRS 160.350(4) so as to "roll-over" the expiration of the term of the employment of Marvin Moore as SUPERINTENDENT until June 30, 2015;

WHEREAS, the Board has reviewed the terms of the CONTRACTUAL AGREEMENT, as modified, entered into as above referenced;

NOW, THEREFORE, in consideration of the foregoing premises, IT IS HEREBY COVENANTED, CONTRACTED AND AGREED in this ADDENDUM TO THE CONTRACTUAL AGREEMENT as follows:

A. TERM OF EMPLOYMENT

That the term of the CONTRACTUAL AGREEMENT is ratified and confirmed to expire on June 30, 2015.

C. COMPENSATION

The SUPERINTENDENT'S annual salary for the 2012-13 school year shall be increased by Nine Thousand Six Hundred Dollars (\$9,600).

The BOARD may further grant merit adjustments to the salary of the SUPERINTENDENT during the term of this CONTRACTUAL AGREEMENT; however, in no event shall the SUPERINTENDENT be paid less than the salary as adjusted above. Any salary increase is at the sole discretion of the BOARD and the SUPERINTENDENT holds no expectation that any increase will occur. Any salary increase shall not be read to amend or extend the term as extended of this CONTRACTUAL AGREEMENT. All salary increases shall be for future services. No retroactive raises or increases shall be granted.
