ASHLAND, KENTUCKY
CONTRACT EMPLOYING SUPERINTENDENT

This CONTRACTUAL AGREEMENT, made and entered into effective the 1st day of July, 2013, by and between the BOARD OF EDUCATION OF BOYD COUNTY (hereinafter the "BOARD"), and R. BROCK WALTER (hereinafter "SUPERINTENDENT"), and authorized by action at a lawful meeting of the BOARD held on the 25th day of April, 2013.

WITNESSETH:

NOW, THEREFORE, the BOARD and SUPERINTENDENT, for the consideration herein specified, agree as follows:

IT IS AGREED:

1. TERM OF EMPLOYMENT

SUPERINTENDENT is hereby hired and retained for a term commencing on July 1, 2013, through June 30, 2017, as Superintendent of Schools for the County Schools, Boyd County, Kentucky.

2. DUTIES

The duties and responsibilities of the Superintendent shall be all those duties incident to the Office of Superintendent imposed by the law and regulations of the Commonwealth of Kentucky and in keeping with Board policy. Other duties and responsibilities as may be needed from time to time may be assigned to the SUPERINTENDENT by the BOARD.

3. OUTSIDE ACTIVITIES

SUPERINTENDENT shall devote himself exclusively to his duties.

The SUPERINTENDENT and BOARD recognize the advisability and on occasions the necessity of SUPERINTENDENT to attend seminars, courses, or programs conducted or sponsored at the local, state, or national levels. It is understood and agreed that the district shall permit a reasonable amount of time for the SUPERINTENDENT to attend such meetings, for the BOARD to pay for necessary fees and travel and subsistence expenses, as may be approved by the BOARD or as may be set forth in local Board policy. This provision shall be limited to seminars, courses, or programs that would be for the benefit of the Boyd County Schools. The BOARD shall have ultimate discretion in determining the SUPERINTENDENT's attendance and the amount of money to defray reasonable and necessary travel and subsistence expenses.

However, if the SUPERINTENDENT elects to attend any function, meeting, seminar, or program wherein he is compensated as a lecturer, consultant, or for such attendance, the time involved with such functions shall not be considered as part of the 240 required working days and the BOARD shall not pay the SUPERINTENDENT's expenses involved with such functions.

4. COMPENSATION

The salary shall be \$101,000.00 per school year. The salary shall be paid in bi-monthly installments on the same dates as administrators who work twelve (12)

- b. Leaves The SUPERINTENDENT shall accrue all leave days as authorized by Board Policy for certified employees.
- c. Expenses The BOARD shall pay or reimburse SUPERINTENDENT for reasonable expenses approved by BOARD and incurred by SUPERINTENDENT in the continuing performance of his duties under this AGREEMENT, as determined by the BOARD and according to Board Policy.
- d. Professional Dues The BOARD recognizes the mutual benefits derived by the SUPERINTENDENT and the BOARD of the SUPERINTENDENT's membership in certain professional organizations. The BOARD agrees to pay dues for the Kentucky Association of School Administrators (KASA).
- e. Automobile Expenses The SUPERINTENDENT shall be paid a \$650.00 per month vehicle allowance.
- f. Retirement Benefits The SUPERINTENDENT shall have the same retirement benefits as provided all other certified employees under the Kentucky Teachers Retirement System and as in Board policy.
- g. Health Insurance The SUPERINTENDENT shall have the same health insurance benefits as provided all other certified employees under Board policy.

6. TERMINATION OF EMPLOYMENT AGREEMENT

This AGREEMENT may be terminated as per the Board's Policy and shall

also include the following:

- a. By expiration of its term;
- b. Mutual agreement of the parties;
- c. Discharge for cause.

BOARD POLICY

The SUPERINTENDENT's duties and obligations are governed by Board policy, unless otherwise specifically modified hereinabove.

All benefits of the SUPERINTENDENT are specifically spelled out in this AGREEMENT and override any general policy which might be in existence for other employees

SAVINGS CLAUSE

If, during the term of this AGREEMENT, it is found that a specific clause of the AGREEMENT is illegal under federal or state law, the remainder of the AGREEMENT not affected by such a ruling shall remain in force.

MISCELLANEOUS

This AGREEMENT has been executed in Kentucky, and shall be governed in accordance with the laws of the Commonwealth of Kentucky in every respect.

Paragraph headings have been inserted for convenience or reference only, and if there shall be any conflict between any such headings and the text of this agreement, the text shall control.

This AGREEMENT shall be executed in duplicate originals.

This AGREEMENT contains all of the terms agreed upon by the parties with respect to the subject matter of this AGREEMENT and supersedes all prior agreements, arrangements, and communications between the parties concerning such subject matter, whether oral or written.

ASHLAND, KENTUCKY SECOND AMENDMENT TO
CONTRACT EMPLOYING SUPERINTENDENT

This SECOND AMENDMENT TO CONTRACTUAL AGREEMENT is made and entered into this 24 day of June, 2014, by and between the BOARD OF EDUCATION OF BOYD COUNTY (hereinafter the ABOARD@), and R. BROCK WALTER (hereinafter ASUPERINTENDENT").

WITNESSETH:

WHEREAS, The parties hereto entered into that certain Contractual Agreement effective July 1, 2013 and that certain Amendment to Contractual Agreement dated June 24, 2014 (hereinafter collectively "Contractual Agreement"); and

WHEREAS, the parties hereto desire to amend the terms of said Contractual Agreement relating to the Superintendent's compensation and Commonwealth of Kentucky increases in compensation for all certified employees.

NOW, THEREFORE, the BOARD and SUPERINTENDENT, for and in consideration of the mutual terms and conditions set forth in this amendment and those set forth in the Contractual Agreement, agree to amend the above-described contract as follows:

1. The first sentence of Paragraph 4 is hereby amended to state:

"Effective July 1, 2014 the salary shall be \$102,010.00 per school year. Further, for all school years after the 2014/2015 year, the Superintendent shall receive the same increases in compensation as may be provided by the Commonwealth of Kentucky from time to time to all other certified employees of the Boyd County School District."

2. Paragraph 5(a) is hereby amended to state:

Working Days It is understood and agreed that each school year, from July 1 through June 30 during the term of this AGREEMENT, shall consist of 234 working days. If the SUPERINTENDENT elects to be away from the job for five (5) or more days consecutively, this shall be subject to BOARD approval. Days not worked by the SUPERINTENDENT shall be noted in the minutes of the next regularly scheduled BOARD meeting after said days are taken.

3. Paragraph 5(d) is hereby amended to state:

Professional Dues The BOARD recognizes the mutual benefits derived by the SUPERINTENDENT and the BOARD of the SUPERINTENDENT's membership in certain professional organizations. The BOARD agrees to pay dues for the Kentucky Association of School Administrators (KASA) and the Kentucky Association of School Superintendents (K.A.S.S.)."

4. All references in the Contractual Agreement to 240 working days shall be amended to be 234 days as of July 1, 2014.

5. Unless specifically amended hereby, the terms and conditions of that certain Contractual Agreement effective July 1, 2013 and the Amendment to Contractual Agreement dated June 24, 2014 by and between the parties hereto shall remain as stated therein.

WITNESSETH:

WHEREAS, The parties hereto entered into that certain Contractual Agreement effective July 1, 2013; that certain Amendment to Contractual Agreement dated 26th of November, 2013; and that certain Second Amendment to Contractual Agreement dated 24th of June, 2014 (hereinafter collectively "Contractual Agreement"); and

2. Paragraph 5(e) entitled Automobile Expenses is hereby deleted in its entirety

3. Unless specifically amended hereby, the terms and conditions of that certain Contractual Agreement effective July 1, 2013; the Amendment to Contractual Agreement dated 26th of November, 2013; and the Second Amendment to Contractual Agreement dated 24th of June, 2014 by and between the parties hereto shall remain as stated therein.
