

IMS Updates: GradeCam

- ❖ Pearson is pleased to announce the launch of our new GradeCam integration with CIITS! GradeCam is a 3rd-party software that allows educators to score Multiple Choice and True/False assessments by using document/web cameras.
- ❖ If your district or school does not already have a GradeCam license, you can still sign-up for a free GradeCam account that allows you to score assessments containing 10 questions or less.
- ❖ **Schools or Districts wanting to take advantage of this new integration (whether free or paid), will need to contact [Maritta Horne](#) so that we may set up the synchronization of data between GradeCam and CIITS.**


