- ▶ **2014–2015 Assessment Data Loaded and Published to districts include:** AP, K–Prep, Stanford 10, EOC, Growth, CCR, Kindergarten Readiness, Explore, Plan, Access, ASVAB, KOSSA, NCRC, Industry Certification, Compass KYOTE, ACT National, ACT Junior. ACT National and Junior Test – published only to those districts that have selected to receive them. We now can exclusively publish data for a specific school year.
- ▶ **2015–2016 Assessment Data Loaded and Published to districts:** Kindergarten Readiness assessment, ACT National (September and October 2015).

# Data Security – Passwords

Your password is the key to your online life. Insecure passwords are the same as leaving your doors unlocked. Here are some easy ways to make your life safer, without being too hard to remember.

- ▶ Never use “password” or anything remotely like it. No amount of numbers or letter substitutions will make this secure. Also, any consecutive number or letter combination should be avoided.
- ▶ Do not use personal information. No birthdays, phone numbers, addresses, anniversaries or Social Security Numbers should be your password. And not just yours, but your family and pets also.
- ▶ Avoid words that are listed in the dictionary, even in combinations.
- ▶ Instead of a password, use a “pass phrase” or group of words and numbers, which is then enhanced or abbreviated with numbers and special characters.

# Internet Explorer and Campus

- ▶ As of June 2016, Campus will no longer support IE 9 and 10. Internet Explorer 11 will be the Campus supported version going forward.
  - Based on security change announcement from Microsoft Support
  - Support for Microsoft Edge will be announced once testing and updates have been completed.

- ▶ KDE entered into agreement with Cabinet for Health and Family Services to provide data on foster care students.
- ▶ Should minimize need for districts to provide individual student records.
- ▶ Exception may be for district administered assessments that KDE is not party to.
