

- Calendar: This will default to the current school calendar.
- Schedule: If the school only has one schedule, assign the student to the schedule named "Main." If the school has multiple schedules, the student must be assigned to a schedule designated for preschool students.
- Grade: Grade codes 95 for infant and 96 for one-year-old should NOT be used in state- funded
 preschool programs. These state grade levels will not receive preschool funding. The state grade
 level should correspond to the student's age as of August 1st. Grade code 97 for two-year-old, 98
 for three-year-old and 99 for four-year-old. Students who are five years old before August 1st will
 not receive preschool funding.


