

Custom Assessment Report - The purpose of this report is to allow school/district staff to see students' results on major assessments by content area. The report includes students with primary enrollments who completed the academic year in your school/district. The numbers will not always match the School Report Card (SRC); however, data is broken down into similar aggregated groups.

To generate the report:

1. Choose the Year and the school (choose All schools to select the District) from the Campus Toolbar.
2. Select the type of report – Aggregate or Detail (For ACT, Explore or Plan, you can also choose to include Benchmark data).
3. Choose one assessment – KPREP, EOC (End of Course), ACT, Plan, Explore, Stanford 10 or Advanced Placement.
4. Choose one subject or all (options are based on the assessment chosen).
5. Choose one grade or all (options are based on the assessment chosen).

Notes:

- *Users must be granted access by local KSIS administrator before they will see this report.*
- *The data in this report will change as scores are imported into State Edition of Infinite Campus.*
- *ACT scores are pulled from the "STATE" sponsored ACT that is administered to all Juniors in March – it **does not** include National Scores.*
- *AP report data is used to meet school report card reporting requirements.*

Report Specifics:

- **Aggregate** report will provide performance data by demographic groups.
- **Detail** report lists all of the students and their test scores included in the aggregate report numbers.
- Specifics for individual assessments:
 - ACT - if multiple scores exist, the highest scale score will be reported (only for the Jr ACT assessments).
 - K-PREP, EXPLORE or PLAN - if multiple scores exist, the most recent scale score will be reported.
 - K-PREP (grades 3-8) or EOC, the number of students tested in the subject area including the number for each proficiency level (Novice, Apprentice, Proficient, and Distinguished) will display for subject area selected.
 - ACT, Explore and Plan - the average score of students that have taken the applicable test is displayed along with number meeting benchmark (if selected). Note: Kentucky last administered Explore and Plan in SY 14-15.
 - Stanford10 - the average score of students that have taken the applicable test is displayed.

- Advanced Placement – displays course enrollment, course completion (credit attempted on transcript), assessment participation and score data. The aggregate report groups by the state code and shows the state course name. The detail report includes the local course number and name. The report selects students based on AP course participation. Those testing without a corresponding course are not reported.

Suggested uses: (Once report is opened in Excel, turn Filter option on.)

- Run the aggregate report to see school-level scores by subject, grade-level, race/ethnicity, and gap groups. Detail report provides corresponding student-level detail.
- For EXPLORE, PLAN and ACT aggregate reports, you can also include Benchmark data. The **Benchmark Met** column will report the number of students who “Met” the benchmark if the benchmark has been met on any assessment for ACT, EXPLORE and PLAN.
- For the Advanced Placement,
 - Aggregate report
 - Verify that the report shows all schools offering AP courses.
 - Check for courses with low **% Tested**. Verify that the course has the correct state code.
 - Check for courses with **% Tested** over 100. Use the detail report to correct transcripts for students who did complete.
 - Check participation in courses and testing by demographic groups.
 - Detail report
 - Verify that the report shows all AP courses offered.
 - Compare **Local Course Name** and **State Course Name**. If the course is not actually AP, update the course settings to the appropriate state code.
 - If missing or non-AP courses are found, work with the person who defines courses to correct the state code.
 - Check students who did not complete the course. If the student did not drop the course, verify that corresponding transcript entries contain the local course number and correct state code.
