<u>Custom Report: Preschool Quality Assurance</u> – The purpose of this report is to allow school and district personnel to generate a report to verify preschool counts. This report is intended for internal use only, these reports contain sensitive data and must be handled appropriately.

<u>Selection Criteria</u>: Use the Campus toolbar to select the school/academic/calendar year you would like to use for the report. If you are looking for multiple schools or calendars, choose "Select All". Selecting "All Years" will not work. Choose Detail Report or Aggregate Report. Select the Individual Aggregates checkbox for aggregates by school. If not selected, the aggregate will be district-wide. The reports will show students currently enrolled or enrolled on the last day of school of the reported year.

Report Sample: The Detail report will generate in Excel format. Each row provides data for a single student. The fields provided are: Academic Year, District Number, District Name, School Number, School Name, SSID, Last Name, First Name, MI, Birth Date, Age as of August 1st, Grade Level, Grade Description*, Enrollment Start Date, Preschool Start Date, Gender, Race Ethnicity, IEP Start Date, IEP End Date, IEP End Date, IEP Status, Primary Disability, Disabled State Fund, Head Start, State Funded at Risk, Head Start Enhanced, Over Income Preschool, Other*, <u>Home Language</u>*, Enrollment Type, and Report Run Date.

*Field-Level Definitions:

- Grade Description: provides detailed description of the reported State Grade Level (e.g., 99 = preschool 4 yr).
- Other: is a funding source different than one of the default choices as specified by the district (e.g., Preschool Partnership Grant).
- Grade Level: provides detailed description of the reported State Grade Level (i.e., 99 = preschool 4 yr).

- Preschool Start Date: is reported as the day the student starts their preschool classes. This is different from their enrollment date. This is different from their enrollment start date.
- Home Language: is defined as the student's primary language. This could determine if a student is receiving English Language services. A list of the Infinite Campus Home Languages can be found in the <u>Library of Congress Standards</u>.

Suggested report uses:

Detail report

- Review preschool counts to ensure accuracy.
- Review student detail to ensure accuracy of gender, race/ethnicity and grade level. School/district reporting will be disaggregated by grade, gender and race/ethnicity.
- Share aggregated pdf with district/school leadership for awareness and additional quality assurance.
- Resolve errors identified in the error report to maximize quality of data.
- If a student is missing or not reporting correctly, run the Error Report to see a description of items needing correction. Aggregate Report:

• Share aggregated PDF with school and district leadership for awareness and additional quality assurance.

Error Report

- Items highlighted in yellow indicate an error that should be reviewed. Resolve errors to ensure preschool records are accurate. Items highlighted in orange indicate a warning and should be reviewed but it may not need a correction.
- Only one error will show per student. Fixing an error might result in additional errors showing on student.
- Verify IEPs have a primary disability, status, and least restrictive environment (setting).
- Ensure the IEP is locked.

- IEPs with start and end dates which overlap another locked IEP should be avoided.
- If the student has an active IEP, check the student's latest enrollment record to ensure the Special Ed Exit Status and Special Ed Exit Date fields are empty.
- Verify students are reporting the correct disability status and grade for their ages.
