## January Growth Factor

The January Growth Factor reporting will resume for the 2023-2024 school year and must be submitted to KDE five days after the last day of the school month chosen with the most attendance days in Jan. of the current school year. Still, no later than Feb. 20. The report includes the following information for the school month chosen with the most attendance days in Jan. of the current school year: aggregate days attendance and absence; race and gender count; home and hospital; adjustments for less than full-time attendance (partial day); nonresident/non-contract students; and overage and underage students. All information is reported by school, grade level, and transportation code.

The *January Growth Factor Report* should be submitted via the [SAAR application](#). Please review the steps in the [Submission Guide](#) to ensure all data cleanup is complete. To determine if your district's enrollment increased enough to qualify for the *January Growth Factor*, see page 29 in the submission guide.

## KSIS data standards

The KSIS data standards should be used by and shared among everyone responsible for entering information into Infinite Campus. The data collected in the system is used by KDE and education leaders at all levels to meet reporting requirements, for decision-making, and funding allocations, and is shared as longitudinal data between systems. Specific data elements must be collected in a standard and consistent manner to ensure the information is accurate and complete.

Data standardization is the process of making all data of the same type or classification conform to an established procedure, to ensure consistency and comparability across different databases. KDE publishes data standards to provide guidance to school districts with data entry and improve data quality in Infinite Campus.

The standards are available to view or download on the [KDE KSIS Data Standards webpage](#). The standards are updated as new data elements are added or changed and each standard has a revised date. If you need additional assistance entering or understanding any data element or set of elements, contact the data steward whose contact information is included in the standard.

## Civil Rights Data Collection 2021-2022

Each local education agency (LEA) must submit and certify its data by the Feb. 26 closing date. All Civil Rights Data errors must be fixed before certification. The timeline and helpful resources can be found on the [KDE CRDC webpage](#) and the [CRDC Resource Center webpage](#).

If you have not started validating, submitting missing data, and fixing errors, please do not wait. There are a lot more reporting errors this year due to skipped logic. Some warnings have been updated to errors in this collection to ensure LEAs are reviewing the indicator, guiding questions, and the answers in skipped fields.

## Do students in your district have the information they need for college going/eTranscripts?

According to national trend data, students are not applying to as many colleges and universities as they did in previous years. Please ensure that your students know how to take the next step for college and how to order a transcript so these are not among the reasons for the downward trend. Counselors and records clerks should consider the following questions.

- Is there a plan in place for communicating with students and families throughout the students' senior year? If not, Campus Messenger can be used to communicate through the portal and email. See [Council on Postsecondary Education \(CPE\) Campus Messenger Documentation](#) for scripted messages that can be sent to students meeting or exceeding minimum admission requirements.
- Are students and families being reminded to submit their [FAFSA](#)? The 2024-25 FAFSA window opened Dec. 2023 and [included changes](#) for the upcoming year. [FAFSA completion by High School and Public School District](#) is available.
- Are students familiar with the transcript request process? The customized Parchment link should be available on district and high school sites. See Parchment's [Implementation Steps](#) for custom order link setup instructions and a video tutorial.
- Are school social media sites being used to promote college going and transcripts?
- Do students know that they must request a final transcript after grades have been posted and graduation status is updated? Develop a plan for releasing transcripts over the summer to avoid delays.
- Is it clear how alumni should request a transcript on the school's website, will they be able to order their transcript online?
- Is there good information on the website that can be referenced and included as a hyperlink in messaging?

Act now to ensure that your district can answer these questions and has a good plan in place to promote college-going best practices. More information about eTranscripts and Parchment can be found on the [KDE eTranscripts webpage](#).

In this one-hour webinar, speakers from the U.S. Department of Education will discuss privacy requirements and reinforce best practices for schools and districts, ranging from legal basics to cybersecurity considerations to employee privacy concerns.
