Please be advised that KDE has confirmed the scheduled release of **E.1521.3 and E.1525.3** to all Kentucky Infinite Campus production and sandbox environments to start **Wednesday, July 8 at 7:00 p.m. (Central)/8:00 p.m. (Eastern)**. Infinite Campus will be temporarily unavailable during the update process. Please contact me if you have any questions or concerns about the update schedule.

<b>Early Learning/Prior Setting</b>	<ul style="list-style-type: none"> <li>• Early Learning/Prior Setting name search updated to recognize special characters</li> </ul>
<b>Safe Schools</b>	<ul style="list-style-type: none"> <li>• Logic for the Safe Schools Extract has been updated to report event data from the Behavior Incident Calendar ID instead of Behavior Event Calendar ID to ensure events modified and re-saved in a calendar outside the reporting year and parent incident report correctly within the extract.</li> </ul>

<b>Ad Hoc Filter Designer</b>	<ul style="list-style-type: none"> <li>• School Boundary fields have been added to the Query Wizard.</li> </ul>
<b>Campus Instruction</b>	<ul style="list-style-type: none"> <li>• The Roster Verification tool has been added. This tool allows districts to create roster verification events in which teachers can certify the amount of time spent with students through Campus Instruction.</li> </ul>

<b>Health</b>	<ul style="list-style-type: none"> <li>• The Student Health Screenings tab has been updated as follows: <ul style="list-style-type: none"> <li>○ Screenings History display now shows sub-screening data where appropriate. A sub-screening is a screening type that requires data entry into multiple screening editors (like Early Childhood or Health Appraisal).</li> <li>○ The Batch Health Screening has been renamed to Health Screen Batch Entry and now allows entry of Dental screenings.</li> </ul> </li> </ul>
<b>Preschool</b>	<ul style="list-style-type: none"> <li>• Logic for the Preschool Enrollment Count Extract has been updated to no longer reference Evaluation documents when generating data. Now, a student’s disability status is only determined by their locked IEP.</li> </ul>
<b>Safe Schools</b>	<ul style="list-style-type: none"> <li>• Error 04 of the Safe Schools Extract was failing to report students whose behavior incident occurred while they were enrolled in the reporting district but not in the calendar where the incident took place. Logic has been updated to report students whose behavior incident occurred while they were enrolled in one of the selected calendars for the Safe Schools report.</li> </ul>
<b>Scheduling</b>	<ul style="list-style-type: none"> <li>• Corrected issue where multiple term schedules were causing attendance events to incorrectly be displayed multiple times, once for each term schedule, on the Daily Detail and Attendance Profile reports under the Attendance tab.</li> </ul>
<b>Special Education</b>	<ul style="list-style-type: none"> <li>• A new Evaluation has been added for Kentucky which combines the Consent form and the Conference Summary - Initial with traditional Evaluation functionality. The Eval Type for this new document is KY Evaluation 2015 (current). (see full release notes for details)</li> <li>• The previous IEP plan types that varied by age have been consolidated into a single plan type. The print format for this</li> </ul>

	<p>document is 'KY IEP 15 Format (current)' and the document available using that print format is called 'KY IEP'.</p> <ul style="list-style-type: none"> <li>• The Progress Report, PSP, and Test Accommodations Report have also been updated based on state requirements. A new print format for the PSP called 'KY PSP 15 Format (current)' has been added - the document is called 'Private School Service Plan.'</li> <li>• Selection criteria for the KY IDEA Dec 1 Count Extract has been updated. (see full release notes for details)</li> </ul>
<b>Unaccompanied Youth</b>	<ul style="list-style-type: none"> <li>• The Unaccompanied Youth field has been added to the State Reporting Fields section of the Enrollment tab.</li> </ul>

<b>Instruction Module (Java Gradebook)</b>	<ul style="list-style-type: none"> <li>• <b>The Instruction module has been removed from Campus with this release. Teachers will need to be given access to Campus Instruction.</b></li> </ul>
<b>Campus Instruction</b>	<ul style="list-style-type: none"> <li>• The Settings menu in the Grade Book has been reorganized to sort tools into related sections.</li> <li>• A "Custom Links and Reports" section has been added to the bottom of the Campus Instruction outline, above Account Settings. This tool collects the links and reports added by the administrator.</li> </ul>
<b>Scheduling</b>	<ul style="list-style-type: none"> <li>• With the removal of the Instruction module in this release, The Default Grade Book Task checkbox on the Course Grading Task and Standards tabs is no longer relevant and has been removed. The Campus Instruction Grade Book saves the current location of a teacher and returns them to that Term/Section/Task context when the Grade Book is reopened.</li> </ul>
<b>Health</b>	<ul style="list-style-type: none"> <li>• The Student Health Screenings tab has been updated as follows: <ul style="list-style-type: none"> <li>○ New screening editors for Lead, Social-Emotional and Concussion have been added.</li> <li>○ Existing screenings have been updated to capture required data.</li> <li>○ All historical screenings display in chronological order with the most recent screening first.</li> <li>○ Follow-up/Referral fields have been added to individual screening entries.</li> <li>○ New print options have been added to report all screening information, screening information for the selected year, or screening information for just the selected screening.</li> <li>○ All screening fields have been added to the Filter Designer.</li> <li>○ New Campus Sub-Reports and Campus Fields have been added to the Letter Designer and Letter Builder tools.</li> <li>○ The Health Screenings Compliance Report has been updated to include the new screenings.</li> </ul> </li> </ul>

	<ul style="list-style-type: none"><li>○ A Health Screening Batch Entry tool has been added to enter hearing, vision, scoliosis and dental screenings by either a grade level or by teacher/course section.</li></ul>
