Digital Repository	<ul style="list-style-type: none"> The Campus Digital Repository Instruction Usage Report allows you to select whether you want to sort report results by User or by File Type. Path: System Administration > Digital Repository > Reports > Instruction Usage Report When entering the Digital Repository Preferences tab, users are briefly shown the Digital Repository Preferences screen before almost immediately being redirected to the Campus Digital Repository Terms of Services pop up. The user will see the PDF immediately if the user has not accepted the terms of service. When the user accepts the terms of service the Digital Repository screen displays. Finance	<p>A new Journal Entry Upload tool was added. <i>Path: Finance > General Ledger > Processing > Journal Entry Upload</i></p>
FRAM	<p>When users were generating a new Verification for the year and printing the 1st Pre-Notice letter, the system was printing the Verification Report instead. This issue was fixed. <i>Path: FRAM > Verification</i></p>
Grading & Standards	<p>The CurriculumStandard.stateStandard field for Credit Types has been updated to no longer allow a null value, with a default value of 0. All existing null records have been converted to a value of 0. <i>Path: N/A</i></p>
Health	<ul style="list-style-type: none"> When entering special conditions for vaccines, all fields on the editor must be populated (except the Day field) in order to save the data correctly to the database. <i>Path: System Administration > Health Vaccine</i> The Generic Immunization Extract has been updated to respect the maximum characters allowed for Grade Levels, which is currently 4. <i>Path: Health > Reports > General Immunization</i> The option to remove Census Data from the printed format of the Generic Immunization Extract in PDF format is now available in the CSV and XML formats. <i>Path: Health > Reports > Generic Immunization Extract</i>
Instruction	<ul style="list-style-type: none"> Previously, Report Card Comments sometimes displayed in the Percent column of the Grade Book. This has been corrected. <i>Path: Campus Instruction > Grade Book</i> Updates have been made to the Missing Assignments Report in Campus Instruction and Instruction. <i>Path: Instruction > Report; Campus Instruction > Reports (Grade Book)</i> Previously, deleting student groups that were in use caused issues in the Campus Instruction Grade Book. This has been corrected. <i>Path: Campus Instruction > Student Groups</i> Previously, when a Rubric had blank lines, the Grading By Student tool didn't generate a list for grading. This has been corrected. <i>Path: Campus Instruction > Post Grades > Grading By Student</i> Grade Book shortcuts have been updated to function correctly. <i>Path: Campus Instruction > Grade Book</i> Tool sub-rights have been added for Grading Scales, Assignment Marks, and Composite Grades (through the Grade Calculation Options) in the Grade Book Settings. In the past, these three tools lived outside the Grade Book. Note: These sub-rights are turned ON by default. Update sub-rights for users or user groups who don't need access to one or more of these tools.

- A warning has been added alerting teachers when they attempt to post grades that do not match options in the Grading Scale and Score Group.

Path: Campus Instruction > Grade Book > Post

- The Grade Book fill option to fill "Present and Empty" has been updated to function correctly.

Path: Campus Instruction > Grade Book > Expand Assignment > Fill Scores/Comments

- Logic has been added to allow teachers to enter a Weight for a Category of 100% when the section only has one Category. A single Category calculates with a Weight of 100% automatically, but this change makes that logic clearer.

Path: Campus Instruction > Grade Book > Settings > Categories

- Previously, updates to scores in the Campus Instruction Grade Book did not send push notifications through the Campus Mobile Portal application when preferences indicated that they should. This has been corrected.
- The Campus Instruction Grade Book has been updated so that clicking on student names opens a summary of contact information for the student, similar to other areas of Campus Instruction.

Path: Campus Instruction > Grade Book > Student Name

- An additional Method for calculating Proficiency Estimates has been added to the Grade Calculation Options of Most Recent.

Path: Campus Instruction > Grade Book > Settings > Grade Calculation Options

- An option has been added to the Grade Book Settings to allow teachers to include a link to a course web site, which is then available in the Portal. This option was added to Campus Instruction to match existing functionality in the Instruction module.

Path: Campus Instruction > Grade Book > Settings > Web Site Address

- As a result of the enhancement to store In Progress grade in the database, these grades no longer display for previous years. If districts would like these grades to display, please have your Authorized Support Contact submit a support case for more information.
- Previously, if multiple teacher scored assessments were tied to a course, scores entered for assessments would sometimes overwrite each other. This has been corrected.

Path: Campus Instruction > Post Grades

- Previously, the system at times failed to generate a timestamp for each student submission. Logic has been updated to ensure that a timestamp appears for every submission and a script was run to add timestamps for submissions that were missing timestamps.

Path: Campus Instruction > Grade Book

- Previously, the scoring cell for an exempt assignment would only be colored gray if the teacher had turned on pass/fail color coding in the Campus Instruction Grade Book. This logic has been updated so that the scoring cell for an exempt assignment always displays as gray.

	<p><i>Path: Campus Instruction > Grade Book</i></p> <ul style="list-style-type: none"> Logic has been updated so that when teachers hover over flags in the Roster, all comments display for each flag, even if the student has multiple flags for the same condition. <i>Path: Instruction > Roster</i> The Beta label has been removed from the Campus Instruction application. Users should still be aware that Campus will continue to enhance this application as a beta release. This label was removed because it caused uncertainty in what is a robust product. <i>Path: Campus Instruction</i> Previously, when posting In Progress grades from one Grading Task to another overwrote the Report Card Comments in the destination Grading Task. This has been corrected. <i>Path: Campus Instruction > Grade Book > Post</i>
Messenger	<p>The E.1338 release included a Messenger Reports improvement project. As a result, the following reports are now removed from the Campus outline:</p> <ul style="list-style-type: none"> System Administration > Messenger > Email Messenger Log System Administration > Messenger > Voice Messenger Log System Administration > Messenger > Reports > Dialer Activity System Administration > Messenger > Reports > Utilization Report Messenger > Email Messenger Log Messenger > Reports > Dialer Activity Attendance > Dialer Activity <p><i>Path: Messenger</i></p>
Online Payments	<p>Changes were made to increase the security around online payment transactions.</p> <p><i>Path: System Administration > Finance > Payments</i></p>
Performance	<p>Updates were made to improve system performance.</p> <p><i>Path: No Specific Path</i></p>
Point of Sale	<p>An issue was occurring if a point of sale started with a disconnected USB cable, the cash drawer was not opening. This issue was fixed.</p> <p><i>Path: Point of Sale</i></p>
Programs	<p>Users accessing the Academic Planning tools in Pennsylvania did not see the Save and Delete icons in the action bar. This has been corrected.</p> <p><i>Path: Student Information > Academic Planning > Program</i></p>
Security	<p>An update was made to ensure calendar rights were properly enforced when users have the Campus application and Campus Portal both open in the same web browser.</p> <p><i>Path: No Specific Path</i></p>
Transcripts/Report Cards	<p>It was reported that not all selected reporting options were printing when generating the Transcript Batch. This has been corrected.</p> <p><i>Path: Grading and Standards > Reports > Transcript Batch</i></p>
