Please be advised that KDE has targeted the release of **E.1338** to all Kentucky Infinite Campus production and sandbox environments starting **Wednesday, October 9 at 7:00 p.m. (Local Time)**. KDE has also requested Infinite Campus to change the scope year to 2013-14 and this update is tentatively scheduled to occur immediately following installation of E.1338. The change in scope year does not impact school districts, but it will allow synchronization with State Edition. Infinite Campus will be temporarily unavailable during the update process.
