Please be advised that KDE requested and scheduled early release of **E.1350** to all Kentucky Infinite Campus (IC) production and sandbox environments to start **Wednesday, December 18 at 7:00 p.m. (Central Time)/8:00 p.m. (Eastern Time)**. Infinite Campus will be temporarily unavailable during the update process. The early release is necessary for timely implementation of system enhancements necessary to open Individual Learning Plan Addendum (ILPA) functionality to districts participating in the voluntary pilot of the new module. Please see the January 2014 *KSIS and More* newsletter for more information. I apologize for any inconvenience this schedule may cause your district.

<b>SPED</b>	<ul style="list-style-type: none"><li>The following fields have been updated in the Summary Report: Eligibility Determination Date, Re-evaluation Date, and LEP Participation. The Accommodations and Assessments editor of the IEP has also been updated so that the Dimension A and B fields will report from the most recent locked IEP. <i>Path: Student Information &gt; Special Ed &gt; Documents</i></li></ul>
<b>LEP</b>	<ul style="list-style-type: none"><li>The State Value Key has been removed from the LEP tab. This key was read-only informative text and does not impact existing LEP functionality. <i>Path: Student Information &gt; Program Participation &gt; LEP</i></li></ul>
<b>Safe Schools</b>	<ul style="list-style-type: none"><li>The Safe Schools extract was updated to report new board violation codes. In support of the new codes, updates were made to the extract. <i>Path: Behavior Management Tool &gt; Incident &gt; Event &gt; Board Violation; KY State Reporting &gt; SafeSchools</i></li></ul>
<b>TEDS</b>	<ul style="list-style-type: none"><li>CIP code 15.0100 Stem-CIVIL ARCHITECTURE &amp; CONSTRUCTION TECH has been added. (This was also included in 1346 as an Rx patch) <i>Path: Student Information &gt; General &gt; TEDS</i></li></ul>
<b>Core Product Highlights</b>	

<b>Census</b>	<ul style="list-style-type: none"> <li>The District Assignment Title field now saves the corresponding code to the database as well as the title. Any existing titles have been converted to save the code and the title. <i>Path: Census &gt; People &gt; District Assignment</i></li> </ul>
<b>Custom</b>	<ul style="list-style-type: none"> <li>Outline links and Custom Tabs containing URLs to non-Campus sites were not opening. This has been corrected. (This was also included in 1346 as an Rx patch) <i>Path: System Administration &gt; Custom &gt; Outline Links, Custom Tab</i></li> <li>When two entries on a Custom Tab using the Table Editor format exists for the same time and date, data is lost when the second entry is saved. This has been corrected. (This was also included in 1346 as an Rx patch) <i>Path: System Administration &gt; Custom &gt; Custom Tab</i></li> </ul>
<b>Data Warehouse</b>	<ul style="list-style-type: none"> <li>An exception in the Data Warehouse process in which a delete statement within dw_CleanData script was found to not performing as desired. This has been corrected. <i>Path: System Admin &gt; Data Utilities &gt; Data Warehouse Settings</i></li> </ul>
<b>eTranscript</b>	<ul style="list-style-type: none"> <li>Several modifications were made. <i>Path: Transcript &gt; eTranscript</i></li> </ul>
<b>Learner Planning</b>	<ul style="list-style-type: none"> <li>Previously, the Print Editor option did not work for list editors; the Documents tab was running slowly if the school had many calendars; errors were occurring in some Plan editors. These have been corrected. <i>Path: Student Information &gt; Special Ed &gt; Documents</i></li> <li>Logic has been updated so that a teacher who is a team member will see an icon in the IEP or PLP columns of the roster if the plan is locked and active. <i>Path: Instruction &gt; Roster</i></li> </ul>
<b>Point of Sale</b>	<ul style="list-style-type: none"> <li>When using the Print Month feature to print a student's balance and the current month is selected, the Balance as of Date on the report was printing the last day of the month instead of the date on which the report was generated. This problem has been fixed. <i>Path: Point-of-Sale &gt; Account Maintenance &gt; Account &gt; Journal</i></li> </ul>
<b>Portal</b>	<ul style="list-style-type: none"> <li>Previously, different areas of the Portal were rounding grades to different decimal places. This has been corrected so that all fields are rounded to two decimal places. <i>Path: Portal</i></li> </ul>
