### **Time to review district civil rights data**

The Office of Civil Rights (OCR) has reopened the Civil Rights Data Collection (CRDC) website. You can now use the username/password you received from OCR to login and look at the data KDE has loaded to your district. If you do not have your username/password, you will need to contact CRDC Partner Support to get a new username/password.

A new schedule of events has been posted to the [Kentucky CRDC](#) webpage. Please remember to only review the data for the next two weeks. If districts find issues with the KDE loaded data, and KDE must reload any data to the site, then everything entered will be overwritten. If you are happy with the data KDE has loaded and do not want any changes, you can use the “opt-out” feature to ensure KDE cannot push any additional data to your site.

Due to the short time between when the site originally opened and when it crashed, we realize some districts who wanted to opt-out of the KDE data load may not have had enough time to opt-out. If you have received KDE data but do not want it, you have two options: manually overwrite with your own data using file uploads/data entry or contact CRDC Partner Support and they can instruct you how to delete everything uploaded from KDE files.
