## COMBINED ALTERNATE OVERVIEW/ATTAINMENT TASKS (AT) TRAINING OPENS MONDAY, AUGUST 27

The 2018-19 Alternate K-PREP Combined Overview/AT training and online quiz will be available the afternoon of Monday, August 27. The online trainings have been posted to the [Alternate K-PREP Trainings](#) page as they have been in the past. A recorded training provided by Kevin O'Hair from the Kentucky Department of Education (KDE) focuses on the Overview for 2018-19. Jaci Norman and Karen Guettler from the University of Kentucky (UK) will provide guidance on the Attainment Task administration. The videos may take a few moments to load before they are active.

The training consists of two sections which include the Alternate K-PREP Overview and the AT training materials. In Section 1 Kevin O'Hair will focus primarily on material from the overview. In Section 2 Jaci Norman and Karen Guettler will provide material specific to the AT administration. An online quiz will be provided following the completion of training section 2. Once the quiz has been completed, confirm by printing two copies, one to keep in the Alternate Assessment and Accountability Folder (AAAF) and the other should be provided to the district administrator before the Attainment Tasks are handed over. ### **ALTERNATE K-PREP CHANGES FOR 2018-19**

As the 2018-19 school year gets underway the Division of Assessment Support would like to share with teachers and administrators all changes for the new school year. Those changes are as follows:

- ▶ Dimensions (A and B) will no longer be identified or included as part of the Alternate K-PREP assessments. The identification of Dimensions has always assisted with communication barriers and services. Now, all communication will be identified as part of the Individualized Education Program (IEP). During the review of the Kentucky Alternate K-PREP Participation Guidelines, it was determined that communication should be addressed during the initial placement to receive services. Advisory members felt it was not something an assessment should address.
- ▶ Attainment Tasks for reading, mathematics, writing, science and social studies will now offer three answer options instead of four (A, B, C).
- ▶ Revisions made to Senate Bill 1 in 2017 require a college entrance exam be administered at grades 10 and 11. The Transition Attainment Record (TAR) will be required at grades 10 and 11 beginning in the fall of 2018.

### **ALTERNATE K-PREP TEST WINDOWS AND STANDARDS ASSESSED**

The Alternate K-PREP will continue to be assessed during two windows. The following tables identify the testing window and the standards that are assessed for that particular window. Reading, mathematics, writing, and

science are still based around the Kentucky Academic (KAS) for Alternate K-PREP. Social Studies continues to follow Core Content 4.1.
