Automation Is Your Friend (?)

In 2019 we took a large leap forward. In order to help our friends, our fellow TEDS users keep their data clean, we began automating some processes. Since then, in many cases, data has been more accurate than ever. However, some are not aware of these automations. So here, being true to our friends, we provide a list of those that most depend on your accurate data.

1. TERMINATIONS

- Do not enter End Dates on the TEDS tab in IC. EVER.
- Do not remove end dates unless the student is in a class in the pathway in the current year. Otherwise, you are committing a funding violation and risk losing your Perkins funding.

2. FOLLOW UP

- Make sure your students are properly marked as concentrators with the correct credits
- Incorrect data can impact accountability status

3. ATTEND HOURS CALCULATOR (not automated, but useful)

- Use of the calculator can help the accuracy of your data
- You cannot count the same course for the same student in more than one pathway
- You MUST use the master schedule as listed in IC (check with your IC coordinator for assistance)
- We wish to be true to the data as well as to you. Help us help you.

Upcoming Deadlines

It's always good to keep your eyes on the prize. Right now, the prize is a summer break. Along the way, it is important the milestones you will pass and leave behind. The things ahead are always better when those behind don't haunt you. Use the Secondary Schools Timeline on the main TEDS website to make it easier to look forward to the better things without looking back.

June 15	 TEDS End of Year Data entered in IC and imported to TEDS. Remember to check ALL students, not just active Semester Data (credits, student objectives, etc.)
June 30	Career Readiness Data Entered Where Possible
July	 Career Readiness data pulled for the Office of Standards, Assessment and Accountability (OSAA)
August	Follow IC Timeline to begin entering 22-23 Student data on IC-TEDS tab
September 1	21-22 TEDS Data locked for rollover to 22-23

Closing Tasks

Data can tell us many things. Among those things is how well we keep and review data. We truly have tons of data. What data we have and what we can do with it depends totally on whether it is accurate and clean. If our actions tell the wrong story of our lives in education, we are then responsible for the outcome. Our funding helps us further the lives of our students with fidelity. We are CTE. As CTE, there are some things we can do to direct the flow of our river. For example:

- When students are enrolled in pathways,
 - \Rightarrow They should know they are in that pathway (no surprises)
 - \Rightarrow the correct credit hours must be posted. Then, they must be updated when anything about the student record changes.
- When a student earns an industry certification for their chosen pathway, it should be properly entered in TEDS the same school year it is earned.
- Once a student meets the definition of concentrator, that should be properly noted in IC and **imported** into TEDS when it happens.
- You must review and update the data one last time at the end of the school year (before your local IC is locked for the year) to ensure data accuracy

How Clean Is Your Data?

Yes, it's time to exhale. Before you take that deep, cleansing, "it's about time summer got here" breath. Before you run off to find your way, don't forget to close everything down correctly. Again, we have advised each school to have at least two users and the district to have two different users for TEDS. you can begin to breathe easier knowing you have a "partner in crime" watching your back. It is incredibly important that you check and double check your data. TEDS automation will process whatever you provide. Breathe easy. Commit to verifying the following:

- School deadline. Do you know when your school's Infinite Campus will close for the year? If you don't know, find out. You need to complete your last export before that date.
- Credits. Make sure what is in TEDS has been updated to match the transcript (through your final export/ import process) at the end of the year BEFORE you leave for the summer.
- Student Objective. Again, make sure what is in TEDS has been updated to match the TEDS tab in IC (through your final export/import process) Is this student exploring or a concentrator? Are you sure?
- Industry Certifications. Have all attempts at industry certifications been entered in TEDS? Have all the teachers verified that they have provided all information?
- And, finally, don't forget the small print

Small print, part 1: DO NOT remove an end date on the TEDS tab in IC unless the student is currently enrolled in a class in that pathway.

Small print, part 2: if you do remove the end date on the TEDS tab in IC, DO NOT try to put it back, it will not stop the student from being active in TEDS and will be counted as a data violation and possibly a funding violation
