New Data Check Process

There has been a change in data matching in TEDS. While IC does not require an SSN, it is the only common connection for postsecondary institutions (both in-state and out-of-state) to make a connection between student and data. We have found that, as some records are updated to correct the SSN for KEES and other potential scholarship opportunities, they go to pieces. TEDS is now checking both the SSN and the SSID to get those pieces in order. This new check helps ensure that students do not risk losing those funding opportunities. If either the SSID and/or SSN do not match what is already in TEDS or exists in TEDS connected to a different name, you will get the following message:

Error: The specified SSID and SSN combination does not match the SSID and SSN stored on the existing TEDS student Demographic record.

If you see this error, it is most likely that the student does not have the correct SSN in IC. Please follow the steps below:

- DO NOT SEND A SCREENSHOT of the error. It includes both the SSID and SSN.
- 2. DO NOT USE IC TO CHECK FOR ACCURACY.
- 3. To verify the SSN, it is best to use a copy of the SSN card to verify the correct number was entered in IC.
- 4. If it is verified, and there is still an error on import, contact Claude Christian.
- 5. If an error is discovered, correct in IC, then create new export files from IC and import into TEDS.

Help us keep our data accurate. That way, thanks to you, no student will lose scholarship or KEES opportunities.

Important Process Update for 4-course Sequence Selection

The CTE Program of Studies provides a guideline for the required courses for each pathway. It is to be used similarly to a college course catalog. Schools are required to provide the opportunity for a student to become a concentrator and, ultimately, a completer.

Perkins V requires that each pathway offer a sequence of four or more non-duplicated earned technical credits to be considered a pathway. Schools have been asked to provide a basic 4-course sequence in TEDS to ensure they are offering valid pathways. Moving forward, individual schools will be allowed, within guidelines, to go your own way. HOWEVER, there are still requirements. To ensure clean and accurate data, each school must do the following:

- Ensure they are offering appropriate courses in accordance with the current year Program of Studies.
- Ensure courses offered will allow a student to complete the pathway based on the best practice courses listed for each pathway in the Program of Studies, meaning
 - ♦ If a listing shows "and", both courses must be taken.
 - If a listing shows "or", only one course may be counted toward concentrator status, completer status or for postsecondary readiness at both state and federal (Perkins) levels.
- Follow the Co-op regulations as noted in 705 KAR 4:041, Work-based learning program standards, which states a student must fit one of these categories:
 - De enrolled in a course included within the student's chosen career pathway within the same academic year,
 - Observe the second s
 - Be enrolled in an approved pre-apprenticeship program.
- Note that Co-op and/or dual credit cannot be the only 4th course option available to students as all are not able to engage in co-op or dual credit.
- Students may only be enrolled in TEDS for pathways that are offered at the school they are enrolled in.
 - ♦ If the courses are taken at an ATC, the ATC is responsible for TEDS enrollment and data upkeep
 - If the courses are taken at a KCTCS campus, the KCTCS campus is responsible for TEDS enrollment and data upkeep

With these changes, it is important to note that all schools will be responsible for providing proof of offered courses on demand and during any monitoring process to include the enrollment years of any student record under review.

How Clean Is Your Data?

There is an old phrase we all learned: "Garbage in, garbage out". If your data starts clean and stays clean, you don't have to deal with garbage or missed opportunities. Remember, many mistakes are often discovered once it is too late to go back. Stay on top of your data. As you work, consider these points:

- When you enroll students in pathways,
 - ♦ The student should know they are in that pathway (no surprises)
 - ♦ The correct credit hours must be posted. Then, **credit hours must be updated whenever they change on the official transcript** (e.g., end of semester/trimester).
- When a student earns an industry certification for their chosen pathway, it should be properly entered in TEDS as soon as the information is received from the instructor and in the same school year it is earned.
- Once a student meets the definition of concentrator, that should be properly noted in IC and imported into TEDS
 when it happens.
- NO DATA HOSTAGES. Clean data is happy data.

EOP and TRACK Test Ticket Reports

The window for verifying available EOP and TRACK test tickets is now open. Now is the time to check the EOP Test Ticket and TRACK Test reports. Check those tickets early. The flow chart shows how tickets are generated. After February 1, 2025, it will be too late to make changes to test tickets based on school or district level errors. Don't let the sun go down on [you]. Remember: For a student to generate a test ticket, they must meet ALL requirements for the ticket. After this date, if the test ticket is not correctly identified, students can still take industry certifications in order to meet requirements to become state transition ready. Lastly, if the student is an underclassman, there is always next year.
