Agenda Item: Welcome

Presenter: Commissioner Jason E. Glass, Kentucky Department of Education (KDE)

Summary of Discussion:

Glass gave an update on COVID-19 relief money that schools/districts are using. He said another pot of money is available and districts have been asked to put plans together about how to use the funds. Those plans must be submitted by the end of July to KDE. Glass provided updates on masking, vaccinations, etc. He said that he does not have any updates at this time but is hopeful that we will return to post pandemic school. Glass also discussed public health organizations and using their guidance in planning. He discussed the listening tour that he has done across the state, listening to Kentuckians about their educational experiences and input for stakeholders. Ten sessions of the listening tour have been held in English and a Spanish version will be held. Comments by Kentuckians will be compiled and released in a document this fall.

Silman discussed using trauma informed care tools and resilience based throughout our schools. Psychological safety; consistency and predictability for staff and students. This is an ongoing endeavor, not a one-time utilization. We have to listen to our students so we can connect to our students; every second is a moment of opportunity to connect and reengage.
