# Kentucky Department of Education School Counselor Advisory Council (SCAC) Feb. 10, 2022 8:30 a.m. ET Meeting Summary

#### III. Kentucky Board of Education Student Member Application

Toni Konz-Tatman, Chief Communications Officer, Office of the Commissioner, Kentucky Department of Education; and Meredith Brewer, Director of Education Policy, Office of the Commissioner, Kentucky Department of Education: Discussed the application process for teacher and student applications for the Kentucky Board of Education (KBE); students must be a current sophomore and live in the 4th congressional district; discussed the importance of the role and responsibilities with the role; one-year term; deadline is March 7, 2022; a video was shared regarding the student membership application; direct any questions to Konz-Tatman or Brewerat KDE.

#### IV. Kentucky Department of Education Updates

Heather Bushelman, Program Coordinator for Comprehensive School Counseling, Office of Teaching and Learning, Kentucky Department of Education

- Self-care (counselors, colleagues, students): discussion was held regarding the following questions and topics: what is something you have found that works for your own self care; how are your colleagues within your building; how are your students; any concerns or certain topics you need help with; great discussion was held among group members regarding self care for staff, students and themselves; many resources were shared among members.
- LGBTQIA+ Resources: discussion was held regarding the statewide school counselor cadre that was held in January; this was a powerful session for all who attended; discussion of the resources that were provided.
- Reflection on Feb. 8 School Counseling Summit: discussion was held regarding the first statewide school counseling summit; members that participated shared thoughts and feedback from the sessions; the resource guide and recordings will be shared soon.
- Topics for 2022-23 statewide school counselor cadre: discussion of topics, presentators and ideas for next year's statewide school counselor cadre; Kentucky Best Practice Framework for School Counselors; American School Counselor Association National Model; advocacy for district-wide leaders; Tier 1, Tier 2, Tier 3-Multi-Tiered System of Supports; Data Driven School Counseling; ethics; email Heather with more ideas, topics and speakers.
- KDE Counseling webpage update: A page dedicated to Recognized American School Counselor Association Model Program and resources to assist with this process which include videos from school counselors.
- Statewide Data Snapshot: Superintendent Survey data is being analyzed; data was shared from the school counselor survey; discussion was held regarding the data (appropriate vs inappropriate activities) and training needs based off the data for school counselors and district leaders.
- Social-emotional Framework Update: a discussion was held regarding the work and the group; discussion was held regarding a survey that will be sent to collect SEL practices and implementation.
- Mindfulness/Calming Space Grant: \$18,000 grant; total of 18 schools awarded over the next two years; rubric and application are currently being worked on and will be available soon.
- ILP Advisory Council: discussion was held regarding the purpose of the council; discussion was held on how to ensure a more meaningful experience and strengthen the already existing Individual Learning Plan systems and implementation.

## V. Equity Dashboard and State Data and Findings

Damien Sweeney, Ed.D., Director of the Division of Diversity, Equity, Inclusion and Belonging, Office of Teaching and Learning, Kentucky Department of Education: discussion was held regarding the equity dashboard and gave examples of how you can use the equity dashboard with real time data; Sweeney shared that trainings are available regarding the equity dashboard; encouraged exploring KYMTSS; ThomasWoods-Tucker, Ph.D., shared the equity dashboard and the importance of using this tool.
