Agenda Item: Work Based Learning Applications Approval Process

Presenters: KDE Associate Commissioner Beth Hargis, Ed.D.

Summary of Discussion: Beth Hargis provided an overview of the Work Based Learning approval process. There were no questions or concerns raised by the members of the LSAC.

Action Taken: Fletcher asked for a motion to approve the work-based learning application and approval criteria. A motion for approval was made by Tilford and seconded by Mitchell. The motion passed unanimously by a roll call vote.

Agenda Item: Approval of 704 KAR 8:130, Kentucky Academic Standards for Visual and Performing Arts

Summary of Discussion: The council heard the proposal of a new administrative regulation establishing the Kentucky Academic Standards (KAS) for Visual and Performing Arts (VPA) under 704 KAR 8:130.

Action Taken: Fletcher asked for a motion to approve the regulation. A motion to approve the regulation was made by Burchett and seconded by Raleigh. The motion passed unanimously with a roll call vote.

Follow-up Required: Following the LSAC meeting the proposed new regulation 704 KAR 8:130, Kentucky Academic Standards for Visual and Performing Arts will be taken to the Kentucky Board of Education on June 6, 2024, for consideration and action.

Agenda Item: Repeal of 704 KAR 3:303, Required academic standard

Summary of Discussion: LSAC members heard the proposed repeal of 704 KAR 3:303, Required academic standards, which formerly contained all content areas under one single document incorporated by reference. No questions were asked.

Action Taken: Fletcher asked for a motion to approve. A motion to approve the repeal was made by Borchers and seconded by Mitchell. The motion passed unanimously with a roll call vote.

Follow-up Required: The proposed repeal of 704 KAR 3:303, required academic standards, will be taken to the Kentucky Board of Education on June 6, 2024, for consideration.

Agenda Item: Amendment to 702 KAR 3:320, Finance Officer Certification Requirements
