### Pandemic Electronic Benefits Transfer

- Pandemic-Electronic Benefits Transfer (P-EBT) was introduced by the Families First Coronavirus Response Act of 2020 in response to the COVID-19 pandemic.
- Provides reimbursement to children who did not have access to free or reduced-price school meals due to a physical absence for a COVID-19-related reason.
- Since March 2020, P-EBT has provided over \$3.3 billion in food assistance to Kentucky's children.



### 2022-2023 School Year P-EBT

Benefit Period Sept. 1, 2022, through May 11, 2023



### SY P-EBT

- No student will be automatically approved for SY P-EBT.
- Parents/guardians must apply for SY P-EBT via an online application. Applicants are required to enter the child(s) SSID, other identifying information and the number of days/month absent due to COVID-19, and attest to the accuracy of the application.



### SY P-EBT (2)

### Eligibility and Benefit Amount

- Public and private school students who are eligible to receive free/reduced-price meals and missed school due to COVID-related reasons.
- Students enrolled in all virtual learning due to COVID-related reasons and who meet NSLP free/reduced income eligibility.
- Homeschool students who began homeschool due to COVID-related reasons and who meet NSLP free/reduced income eligibility.
- Students are eligible to receive \$8.18 per day.



### SY P-EBT (3)

# DCBS cannot provide SY P-EBT to any student without the school district's validation.

- DCBS will provide school administrators access to a secure online portal to validate student information/absences.
- An instructional email requesting the name(s)/email address(es) of district administrators will be sent soon, with a 2-week deadline for return of information.



### SY P-EBT (4)

### School Administrator Role

- In absence of COVID tracking, administrators may affirm an applicant's claim for P-EBT if the absence was excused.
- School administrators can approve, deny or edit application details.
- If a school district does not validate the absence, the student's application will be denied.
- Training and materials will be provided.
- Email support will be provided.



### SY P-EBT (5)

### **Proposed Timeline**

- Application anticipated to be available mid-July for at least 30 days.
- Administrators will be able to verify absences during application availability period through mid September.
- Benefits will begin issuing mid-August through September.



### Summer P-EBT

### **Enrollment and Eligibility**

- Public school students who were eligible to receive free/reduced price NSLP meals and were enrolled at the end of the school year may receive P-EBT.
- Each eligible student will receive \$120 for the summer period.
- Benefit issuance will occur mid to late August.
- Virtual and homeschool students are not eligible for summer benefits.



### Summer P-EBT (2)

# DCBS cannot provide Summer P-EBT to any student without the school district's validation.

- KDE has supplied CHFS with all student demographics (i.e., DOB, address, etc.).
- School administrators must provide the SSID of each eligible student.
- If data is not received from your district, your students will not receive summer P-EBT.

# Federal Program Lowers Cost of Internet Connectivity for Kentucky Families

- Many Kentucky families qualify for a program aimed at increasing access to internet services for school-age children.
- The Affordable Connectivity Program provides enrolled households with up to \$30 per month for new or existing internet service and a one-time discount of up to \$100 for purchasing a tablet, laptop or desktop computer.
- More than 80% of households in Kentucky qualify.

## Four Kentucky Teachers Named Finalists for Presidential Award

- Four Kentucky educators have been named finalists for the Presidential Award for Excellence in Mathematics and Science Teaching (PAEMST).
- Each year, a national committee recommends up to 108 teachers to receive PAEMST awards.
- For the 2023 state finalists in mathematics, the committee chose Marcus Blakeney of Fern Creek High School (Jefferson County) and Benjamin Molberger of Atherton High School (Jefferson County).
- The 2023 state finalists in science are Matthew Bryant of South Warren High School (Warren County) and Brian Welch of Madisonville North Hopkins High School (Hopkins County).
- The awards program is administered by the National Science Foundation on behalf of the White House Office of Science and Technology Policy.

### 2023 Kentucky STLP Event Breaks Records

- A record-breaking crowd attended Kentucky's Student Technology Leadership Program (STLP) State Championship on April 19.
- Nearly 20,000 students, educators, volunteers, community members and parents gathered at the Central Bank Center in Lexington to watch students from across the state showcase their knowledge, doubling last year's attendance.
- Each year, students demonstrate what they can do with STEAM (science, technology, engineering, arts and mathematics). Students participate in nearly 50 STLP competition areas, including robotics, coding, web design and newscasting.
- More than 13,000 students participated in the day's events.

### **Kentucky Reading Academies**

The purpose of the Kentucky Reading Academies is to increase the reading outcomes for elementary students by providing high-quality, job-embedded professional learning on how students learn to read to K-5 teachers and administrators.



### What Makes the Kentucky Reading Academies Unique?

- Removes financial barriers to create equitable access statewide
- Invests in people, not programs
- Comprehensive and evidence-based
- Transferrable to align with the local curriculum
- Proactive and sustainable
- The Kentucky Reading Academies will be implemented in three phases:
  - Cohort/Phase 1: Fall 2022 Spring 2024
  - Cohort/Phase 2: Fall 2023 Spring 2025
  - Cohort/Phase 3: Fall 2024 Spring 2026



### What is LETRS?

- Determine WHAT to teach to increase student success
- Recognize the reasons WHY some students struggle and learn evidence-based strategies for addressing those struggles
- Know and understand HOW students learn to read and write





### Who is Eligible to Participate?

- Phase 2 open to Kentucky public school educators who work with K-5 students:
  - General K-5 teachers
  - Special educators, English learner teachers
  - Reading specialists (interventionists, coaches)
  - Administrators (340 additional participants)
- CEO rank change opportunities through educational cooperatives



# Kentucky Reading Academies Phase 1 Survey Results

- 95% of the 433 respondents say that they have learned new and relevant information.
- 93% of the respondents say that the information they have learned has helped them to better meet the diverse learning needs of their students.
- Multiple written testimonials shared about classroom assessment gains, student progress, the value of the information teachers are learning and the successful implementation in their classrooms.

#### LETRS - Phase 2 Registration Now Open

Registration for the second cohort of the Kentucky Reading Academies will be open **through Aug. 31**.

Phase 1 participants will not need to register for Phase 2, as they are already enrolled in the professional learning.

<u>LETRS for Educators Phase 2 Registration</u>: This course is recommended for K-5 teachers, interventionists, reading specialists and anyone providing reading instruction or intervention supports to early readers.

<u>LETRS for Administrators Phase 2 Registration:</u> This course is recommended for district leaders, building administrators and instructional coaches.
