**Agenda Item:** Introduction to Learner-Centered Accountability and Assessment Policies and Discussion on Implications for Kentucky

#### **Summary of Discussion:**

During a presentation from Knowledge Works, there was discussion on Learner-Centered Accountability and Assessment Policies. The committee looked at what a School Quality System provides (accountability and assessment policies, assessment data on the school, and identification of students that need help). The committee discussed the importance of meeting the needs of all members (community, parents, teachers and policy makers). The committee

also looked at what the federal government requires in terms of the School Quality System (standards, assessments and accountability).

For the future vision of assessment and accountability, the committee participated in breakout groups to discuss the experiences of these systems and what isn't working well for stakeholders. The themes that arose from these discussions were: the way the system tests students, doesn't serve all students (disabled, socio-economic status, and skill levels), assessments used are all the same, what do these assessments mean for students (not meaningful), doesn't accurately reflect what kids know, isn't applicable to work force or after school focuses, and the timeliness and usefulness of data for teachers.
