

# **KENTUCKY DEPARTMENT OF EDUCATION (KDE) Kentucky United We Learn Council Vibrant Learning Experiences (VLE) Committee**

## Agenda Item: Welcome and Connection

Presenter: Justin Dunning, VLE Chair

**Summary of Discussion:** Dunning initiated the meeting with a connection activity focused on the wintery weather happening across Kentucky.

## Agenda Item: Approve Minutes from Last Meeting and Roll Call of Members

## **Summary of Discussion:**

Snipes gave an overview of past meetings. This included a reminder of the Sept. 18 VLE Committee meeting, which focused on a potential vibrant learning database for community stakeholders. The committee reviewed the Canopy Project and Kentucky's Best Practices as potential frameworks for a future platform or for sharing vibrant learning in the state. In October, members worked asynchronously to develop moonshot proposals, contributing to the November Kentucky United We Learn Council meeting. The committee did not convene in December due to holiday schedules.

## Agenda Item: Cross Committee Collaboration

**Presenter:** Andre Rupp, The Center for Assessment; Jennifer Stafford, KDE; and Kathy Stovall, Chair of Accelerating Innovation (AI) Committee

**Summary of Discussion:** A detailed discussion shed light on the AI committee's design considerations across various levels, including system aspirations, design principles, essential features and operational components. The AI committee presented three workstream proposals, exploring diverse options within accountability systems as part of a learning agenda. The AI committee presented three workstream proposals as part of a learning agenda. Collaboration ideas discussed included: providing feedback and suggesting changes to current drafts, task

prioritization and contributing to research, sharing insights, designing mechanisms to gather key district design data, and reviewing state-level data architecture and resource web space mockups.

**Feedback:** Members highlighted the synergy between the AI committee's work and VLE initiatives, focusing on collaborative efforts to enhance learning. Members provided the AI committee with feedback to question if a list of 12 design principles might be combined or revised to more easily communicate and consider, especially from a district implementation perspective. Concerns surfaced around supporting both early innovators and those districts who may need additional support and scaffolds to create vibrant learning experiences for their students.

#### Agenda Item: Discuss VLE Definition and Next Steps

#### Presenter: Sarah Snipes, KDE

**Summary of Discussion:** Snipes reviewed the draft definition that had been voted on with approval from the VLE committee. Members were informed that the full council would need to meet virtually in the coming weeks to vote for official approval of the definition. Members were given a link to provide their availability to attend the voting meeting.

## Agenda Item: Plan Spring Site Visits and Work Session

**Summary of Discussion:** Snipes introduced a planning document that framed potential lookfors, observations and questions around the current VLE definition. Members were asked to engage with the document to suggest questions of their own that would be shared with all members for notes, etc. during spring site visits. Members were also asked to contribute specific site visit suggestions. Members suggested site visits to schools and districts that represent diversity with students, geographical location and socio-economic resources.
