## **SOCIAL STUDIES ADVISORY PANEL TO MEET**

(FRANKFORT, Ky.) – The Social Studies Standards Advisory Panel (AP) will meet Wednesday, March 7 from 10 a.m. to 5 p.m. ET at the Kentucky Department of Education, 300 Sower Boulevard, State Board Room, Frankfort. The Social Studies Standards AP will continue its work Thursday, March 8 and Friday, March 9 from 9 a.m. to 4:30 p.m. ET at the Administrative Office of the Courts (AOC), 1001 Vandalay Drive, Frankfort.

Senate Bill 1 (2017) calls for the Kentucky Department of Education to implement a process for reviewing all academic standards and aligned assessments beginning in the 2017-18 school year. The current schedule calls for one or two content areas to be reviewed each year and every six years thereafter on a rotating basis.

The Social Studies Standards AP is comprised of 31 members including elementary school, middle school and high school teachers and representatives of postsecondary education and the Kentucky business community.
