SOCIAL STUDIES STANDARDS JOINT SUBCOMMITTEE TO MEET

(Frankfort, KY) – A joint subcommittee, comprised of members from the social studies standards Advisory Panel (AP) and Review Development Committee (RDC), will meet from 9 a.m. – 4:30 p.m. ET, Tuesday, May 1, Wednesday, May 2 and Thursday, May 3 at the Kentucky Department of Education, 300 Sower Blvd., in Frankfort.

Senate Bill 1 (2017) calls for the Kentucky Department of Education to implement a process for reviewing all academic standards and aligned assessments beginning in the 2017-18 school year. The current schedule calls for one or two content areas to be reviewed each year and every six years after that on a rotating basis.

The social studies standards joint subcommittee is comprised of members of both the AP and RDC committees, which are made up of elementary, middle and high school teachers, and members from postsecondary education.
