## **READING AND WRITING STANDARDS ADVISORY PANEL TO MEET**

(Frankfort, KY) – The Reading and Writing Standards Advisory Panel (AP) will meet Monday, June 18 from 10 a.m. – 5 p.m. ET and Tuesday, June 19 from 8:30 a.m. – 4:30 p.m. ET, in Room 413 at the Kentucky Department of Education, 300 Sower Blvd, in Frankfort.

Senate Bill 1 (2017) calls for the Kentucky Department of Education to implement a process for reviewing all academic standards and aligned assessments. The current schedule calls for one or two content areas to be reviewed each year and every six years after that on a rotating basis.

The Reading and Writing Standards AP is comprised of 30 members including elementary, middle and high school teachers, members from postsecondary education and a representative from the Kentucky business community.
