## **COMMITTEE FOR MATHEMATICS ACHIEVEMENT TO MEET SEPT. 7**

(FRANKFORT, Ky.) – The Committee for Mathematics Achievement (CMA) will meet Friday, Sept. 7, from 10 a.m. to 3:30 p.m. ET, in Conference Room #414, 300 Sower Blvd., in Frankfort.

The Committee for Mathematics Achievement was created in 2005 under KRS 158.842 to develop a multifaceted strategic plan to improve student achievement in mathematics at all levels of schooling – pre-kindergarten through postsecondary and adult. The committee also is charged with designing a statewide professional development program that includes summer mathematics institutes at colleges and universities, follow-up and school-based support services to prepare teams of teachers as coaches and mentors of mathematics all school levels to improve student achievement.

The CMA is comprised of 26 members, including the commissioner of education; representatives from postsecondary education, the Education Professional Standards Board, the Education and Workforce Development Cabinet, the executive director of the Center for Mathematics; a representative with a specialty in mathematics or mathematics education; adult education instructors; and elementary, middle and high school mathematics teachers and school administrators.
