(FRANKFORT, Ky.) – The Financial Literacy Revision and Writing Committee (RWC) will meet 10 a.m. – 3:30 p.m. ET Tuesday, Dec. 4 in Room 517 and 9 a.m. – 3 p.m. Wednesday, Dec. 5 in Room 412, at the Kentucky Department of Education, 300 Sower Blvd., in Frankfort, Kentucky.

Senate Bill 1 (2017) calls for the Kentucky Department of Education to implement a process for reviewing all academic standards beginning in the 2017-2018 school year.
