Introduction

The [KECS LEAD Extract](#) is the daily source for the Kentucky Educator Credentialing System ([KECS](#)) LEAD system. The [Issues Report](#) generates a list of issues that should be corrected in Infinite Campus before reviewing the KECS errors. The LEAD Data Report is no longer being updated and will be sunset with the Infinite Campus update planned for Sept. 11, 2024. Please ensure that staff working with LEAD have tool rights to KECS LEAD Extract. For questions regarding LEAD, contact the LEAD Support Team by [email](#). **Please note that LEAD data is now updated in KECS daily.**

LEAD User Guide

After checking these reports and making corrections. login to KECS to review your LEAD data. If you have the appropriate role, you will see LEAD in the top menu bar (Fig. 1).

KECS Roles of Superintendent, Superintendent Designee, HR Director, HR Designee and LEAD Coordinator have access to LEAD. The HR Director and HR Designee can assign roles in KECS if you do not currently have access but need it.

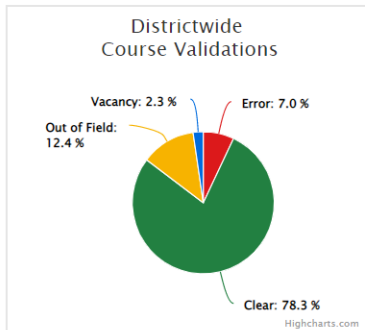

Selecting LEAD from the menu will display Validation Results Courses. (Fig. 2)


Green: Clear (certification covers the content, grade level and disability (special education classrooms only) of student population)

Red: Error (data quality issues that must be corrected in Infinite Campus)

To filter the Course Validation Results displayed under the graph to a specific category, select the colored wedge on the Districtwide Course Validations graph or filter on the district/school (Fig. 3). A district may not have all the possible categories. To filter to a specific school, begin typing the name in the Select a School field or select the school from the list. Select Load.

The top bar of the Course Validation Results will allow you filter multiple ways (Fig. 4)

- To change the number of results displayed, select the double carrot next to 10 and select a different number of results to display.

- Use the Filter option to limit the results to those matching what is typed for all fields displayed.
- Select a heading to sort the results in ascending order of the selected heading. Select the heading again to change to descending order.

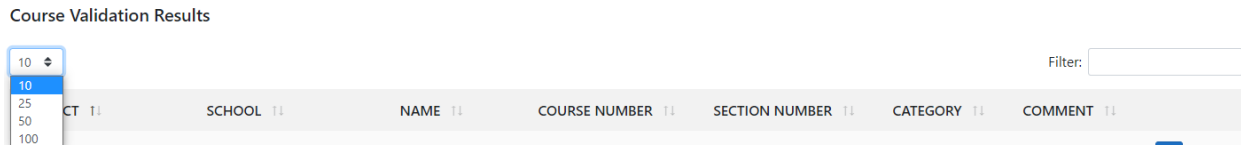
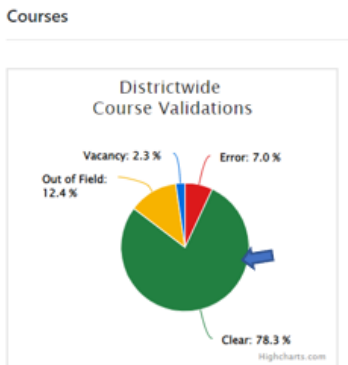

To filter the Course Validation Results displayed under the graph to Clear, select Clear or the green wedge on the Districtwide Course Validations graph. (Fig. 5)

Course Validations Category: Error

To filter the Course Validation Results displayed under the graph to Error, select Error or the red wedge on the Districtwide Course Validations graph. (Fig. 5)

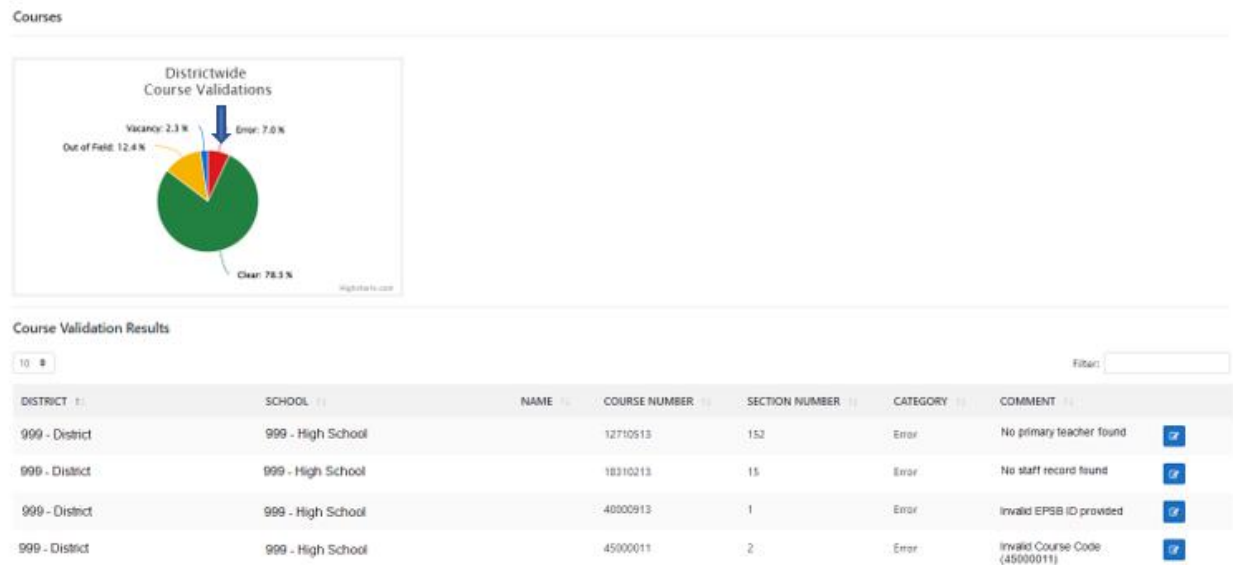

No primary teacher found

- If the teaching position is vacant, assign a vacancy placeholder as the primary teacher per the guidance in the [Census, Staff Information](#) data standard.
- If this is a college offered dual credit course, assign the college professor placeholder as the primary teacher per the guidance in the [Census, Staff Information](#) data standard and ensure the course follows the guidance in the [Dual Credit Course](#) data standard. Verify that the Course Teaching Method is 12: College Offered – Dual Credit (**in IC**).
- If this a placeholder class (state course code of 800500, 909995, 950001 or 960001), assign a guidance counselor or other administrator as the primary teacher (**in IC**).
- If this is an instructional class,

- If students have been or will be scheduled into this class, assign the EPSB certified primary teacher to the section **(in IC)**.
- If this course is not being offered this year, uncheck the Active indicator on the course **(in IC)**.
- If this section is not being used this year, but the course is, delete the section(s) that are not being used **(in IC)**.
- If this is a non-instructional class used to track groups of students for activities, clubs, sports, or testing groups,
 - If the coach or sponsor is EPSB certified, assign them as primary teacher **(in IC)**.
 - If the coach or sponsor is not EPSB certified, assign a guidance counselor or other administrator as the primary teacher and the coach or sponsor as a teacher **(in IC)**.
 - Use state course code **909995: Roster Only Non-Instructional**.
- If this class tracks a teacher's planning time, assign the teacher as primary teacher and use state course code **909995: Roster Only Non-Instructional (in IC)**.
- If this course tracks students that are office/teacher aides, assign the supervising EPSB certified teacher as primary teacher and use state course code **909020: Office/Teacher Aide (in IC)**.

No Staff Record Found

- To be included in the Staff file, a person must have an active District Employment record and an active District Assignments at a school in IC. To identify the person in Campus, go to Search | All People | Advanced Search and enter the PersonID shown in KECS.
 - If the person is an active staff member, update the records following the guidance in the [Census, Staff Information](#) data standard.
 - If the person is not an active staff member, update the primary teacher on the classes **(in IC)**.

Invalid EPSB ID provided

- In IC, the License Number field of the person's active District Employment record contains a value that does not match any existing EPSB IDs in KECS. Follow the guidance for error "No EPSB ID provided" to correct **(in IC)**.

No EPSB ID provided

- Copy the name shown in the Course Validation Results
- To lookup the EPSB ID in KECS, navigate to Administration | Persons. Paste the name into Search and select Search. If this functionality is not available, work with the district HR Director or their designee.
- To lookup the person in IC in a separate window, paste the name into Search | Staff.
- Compare the person's information in KECS and IC to verify that the same person is being viewed in both systems. If a match is not found, the name in KECS may be out of date. Check IC's Census | Identity for other names that may be used in KECS.
- Update the License Number on the active District Employment record **(in IC)** to the correct EPSB ID per the guidance in the [Census, Staff Information](#) data standard.

- When the correct person is found in KECS, copy the EPSB ID.
- In IC, paste the EPSB ID into the License Number field of the person's active IC District Employment record and select Save. If this functionality is not available, work with the district Infinite Campus System Administrator to update the information.

Content required for course code: Not provided

- Courses using state course code of 165698, 230168, 230170, 230171, 499901, 499910, 499915 or 909999 must specify the content area being taught in each section.
 - If course code 909999 is being used for non-instructional classes for tracking groups of students for activities, clubs, sports, testing groups, etc. or teacher planning periods,
 - In IC, search for the listed course number in Course/Section or Course Master if the school uses a course catalog.
 - Update the state course code to 909995: Roster Only Non-Instructional.
 - Course catalog changes must be pushed to the calendars that need to be updated.
 - If the class is instructional,
 - Work with the school/teacher to determine the content being taught.
 - Update the section in IC
 - Search for the listed course number.
 - Select the listed section number.
 - Select the **Core Content** that is being taught and select Save.
 - Do not use content code 507: Non-instructional content or 509: Varies since LEAD will report these as out of field.

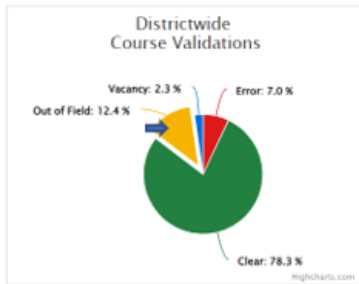

Educator's certification is expired

- To review the teacher's certifications, right click on the hyperlinked teacher's name and select open in a new tab. Does the teacher show an active certificate that applies to the content reported as expired?
- Have the HR Director work with the teacher to ensure that the appropriate applications have been submitted. Progress/Status of an application can be monitored in KECS by district HR staff and the teacher who submitted the application.

Educator does not have permissions for (content)

- If this is a special education classroom and the correct special education teacher is assigned as the primary teacher, change the section's **Special Type** to 05: Special Education Classroom (**in IC**).
- Work with teacher to verify that applications have been submitted for the necessary certifications.
- If this is a college offered dual credit course, using the college professor placeholder (EPSB ID 271) as the primary teacher, make sure that the Course **Teaching Method** is 12: College Offered – Dual Credit (**in IC**). Ensure the course follows the guidance in the [Dual Credit Course](#) data standard.

- If this is a general education classroom, change the section's **Special Type** to 01: None (**in IC**).
- If this is a special education classroom and the correct primary teacher is assigned, work with the Director of Special Education (DoSE) who will use the [Kentucky DoSE OneStop](#) to submit a Program and Teacher Assignment Flexibility form via the secure server for processing.

Educator does not have permissions for (content) within the grade range (low-high)

- If the section has not been used and will not be used, consider deleting it.
- If the content does not match expectations, check the course state code. Use the [Course Search](#) to find the appropriate state code for the content, population, and grade level.
- If the grade range does not match expectations,
 - Check the grade levels of students scheduled into the section number and adjust as needed. LEAD allows up to 25% of students to be outside of the certification grade range.

- Course codes with LEAD Content Area of Principles of Teaching require 5 years of experience. Work with the HR Director to document the teacher's experience in KECS. **District HR staff:** Pull up the educator in KECS, go to PROFILE at the top of page, then under the GENERAL section, click on "Experience". Add at least 5 years of experience in the Experience section. Once updated, the out of field message will update when the validation process is rerun over the weekend.
 - These are the Teaching and Learning pathway courses. If this person has at least 5 years of teaching experience (and is Rank II or Rank I), enter a minimum of 5 years of teaching experience in the EXPERIENCE section of KECS. This experience can be across multiple districts, if applicable.

More than 25% of students for the special education course are general population

- If this is a general education course, change the section's **Special Type** to 01: None (**in IC**).
- If this a special education course,
 - To identify the student(s) reporting as general population, in Infinite Campus run the KY State Reporting | KDE Reports | [LEAD Data](#) Detail report for the sectionID. filter on **Primary Disability in Section** is (Blanks).
 - Work with the Director of Special Education to correct any issues with the student's special education records.
 - If this error is reporting on multiple sections, work with the Director of Special Education to correct issues identified by the [QA SPED](#) Error report for all students.
 - For small classes, this error may persist until an IEP can be completed on a new student or renewed on an existing student whose IEP will expire during the course section.

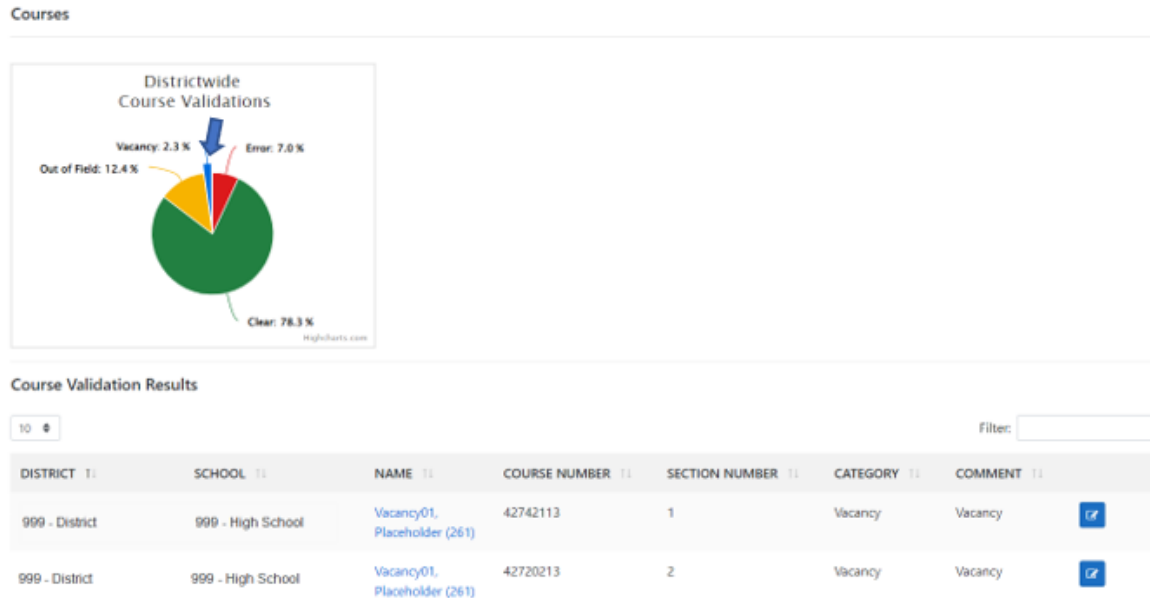
