STUDENTS 09.1222

Nonresident Students

The District shall allow nonresident students to enroll in the District pursuant to existing Admissions and Attendance Policy 09.12, Tuition Policy 09.124, and related procedures.

DEFINITION OF LEGAL RESIDENCE

Residence is established by where the student normally resides. If this is other than the residence of the legal guardian other documentation may be required.

In-district, nonresident students are those who reside within the boundaries of one elementary school zone and send students to another elementary school.

APPLICATION PROCESS (NONRESIDENTS)

Families interested in enrolling their children in the Barren County School District that are not residents of the district should apply online or at the school.

Current and returning students do not need to fill out a new application.

Students whose legal guardians are full time employees of the Barren County School District do not need to apply.

ADMISSION OF NONRESIDENT STUDENTS

Contingent upon the recommendation of the superintendent nonresident pupils may attend District schools when the following requirements have been met:

- 1. The student must be in good standing in the school district from which s/he is transferring.
- 2. The nonresident student is not currently under any disciplinary action from another district (suspension, expulsion, placement in an alternative school).
 - 3. The nonresident student must maintain 96% attendance the previous school year.
- 4. The nonresident student was making satisfactory academic progress (passing 75% of courses attempted).
- 5. Nonresident contracts of agreement must be signed by both parent and student.
- 6. The nonresident student must cooperate with school officials and participate fully in all county, state, mandated testing programs and/or ARC/504 committee.

A nonresident student may be denied enrollment in the district or asked to return to their home district for the next school year if any of the following conditions exist:

- 1. Cap size is exceeded in a class in which the nonresident student is enrolled.
- 2. The nonresident student exhibits behavior that is disruptive to the learning environment.
- 3. The nonresident student does not maintain at least 96% attendance in the course of a school year.
- 4. The nonresident student is not making satisfactory academic progress (passing 75% of courses attempted).

5. The nonresident student does not cooperate with school officials and participate fully in all county, state, mandated testing programs and/or ARC/504 committee.

CAPACITY

A grade level will be determined to be at capacity when the enrollment reaches 98% of the state mandated student to teacher ratio. This will be based on the number of SBDM allocations provided to each school by the board divided by the number of grade levels taught at that school.

TRANSPORTATION

Bus transportation will not be provided outside the borders of Barren County Schools.

NOTIFICATION

Students that are admitted will be contacted by the school Principal/designee to begin the enrollment process. Students that are denied will be notified by the school Principal/ designee. Nonresident students that have not met the expectations for continued enrollment will be notified prior to the start of the school year.

The Board reserves the right to admit and assign all nonresident pupils. Admission will be reviewed annually.
