

Custom Report: Transition Readiness for High School Students – The purpose of this report is to allow school and district personnel to generate a report to monitor transition readiness for high school students. Review the [KDE Transition Readiness Chart](#) for information on requirements. This report does not calculate points for accountability. The Office of Assessment and Accountability (OAA) calculates points for accountability purposes. OAA's determination of Transition Readiness considers multiple factors in the calculation, some of which are not addressed by this report. **This report is intended for internal use only. These reports contain sensitive data and must be handled appropriately.**

Selection Criteria: Use the Campus toolbar to select the school/academic/calendar year you would like to use for the report. If you want data for multiple schools or calendars, choose "Select All". Selecting "All Years" will not work. Choose Detail Report or Aggregate Report. The Detail Report requires a grade level selection. The Aggregate Report runs for graduates only. Select the Individual Aggregates checkbox for aggregates by school. If not selected, the aggregate will be district-wide.

Definitions:

- Academic Ready – Student is both a HS Graduate and On Track for Academic Ready.
- Career Ready – Student is both a HS Graduate and On Track for Career Ready.
- EL During HS – Student was an English Learner at any time during grades 9-12.
- EL Proficiency – Student was an English Learner at any time during high school and has met the ACCESS assessment benchmark.
- English Learners – Student is an English Learner for the school year being reported.
- High School Graduate/Diploma – Student's enrollment end status indicates graduated. Student should also have valid diploma data and diploma type.
- On Track for Academic Ready – Student has met both a benchmark for Quantitative Reasoning/Science (ACT - QR/Science, SAT - QR/Science, Dual Credit - QR/Science, AP/IB/CAI - QR/Science, or TAR – Math) and a benchmark for Communication, Arts & Humanities, or Social/Behavioral Science (ACT - Communication, SAT - Communication, Dual Credit - CAHSBS, AP/IB/CAI - CAHSBS, or TAR - Reading). Note: Academic Ready does not include dual credit coursework for 2017-2018. KDE defined the Academic Dual Credit course state codes to begin in 2018-2019.
- On Track for Career Ready – Student has met any career ready indicator (Valid Industry Certification, KOSSA Articulated Credit, Apprenticeship Completed, or Exceptional Work Experience). CTE Dual Credit and Alternate Career Ready are intentionally left blank and are not being considered by the report at this time. Note: CTE Dual Credit requires two courses from the same pathway, which this report cannot identify.
- Transition Ready – Student is a HS Graduate and Academic or Career Ready and English Proficient, if the student was an English Learner during high school.

Report Sample: The detail report will generate in Excel format. Each row provides data for a single student in the selected grade level. The fields provided are Academic Year, District Number, District Name, School Number, School Name, SSID, Last Name, First Name, MI, Grade, Alternate Assessment, Intent for Early Graduation, Gender, Race/Ethnicity, Diploma Date, Diploma Type, Enrollment End Status, HS Graduate, ACT - QR/Science, ACT -Communication, SAT -

QR/Science, SAT - Communication, KYOTE QR Science, KYOTE Communication, Dual Credit - QR/Science, Dual Credit - CAHSBS, AP/IB/CAI - QR/Science, AP/IB/CAI – CAHSBS, TAR – Reading, TAR - Math On Track for Academic Ready, Academic Ready, Valid Industry Certification, KOSSA Articulated Credit, CTE Dual Credit, Apprenticeship Completed, Exceptional Work Experience, Alternate Career Ready, On Track for Career Ready, Career Ready, EL Proficiency, English Learners, EL During HS, Transition Ready, Economically Disadvantaged, Students with Disability with IEP, Foster, Gifted and Talented, Homeless, Migrant, Military Connected.

Suggested report uses:

Detail Report:

- During the school year, run by grade level to track progression towards readiness after schools post grades to transcript for dual credit courses and when KDE publishes assessment data for ACT, SAT, AP, IB, CAI exams and career readiness indicators.
- After posting graduation data,
 - Run for graduates only. Filter to Transition Ready = 1 to see students who are high school transition ready (HS Graduate and Academic Ready or Career Ready).
 - Run for Grade 12, verify the values in Diploma Date, Diploma Type and Enrollment End Status are correct as needed.
- Filter on the Dual Credit - QR/Science and Dual Credit - CAHSBS columns. If a student has a B or better on a qualifying dual credit course, but shows 0 in the report, verify the state course code on the transcript entry. Refer to the [Searchable State Course Code Database](#) for a list of valid academic dual credit course codes.
- Filter on EL During HS for values of 1. Monitor English Learners for On Track for Academic Ready, On Track for Career Ready and EL Proficiency.
- Note: The report is not evaluating CTE Dual Credit at this time – intentionally left blank. Filter on the CTE Dual Credit column for values of 1. If this is the only indicator for Career Ready, the student may not be Career Ready. Check the student’s transcript to verify the student has two dual credit courses with a B or better in the same pathway. This report cannot verify that the courses are in the same pathway.
- Filter on assessment columns for values of 1 to see who has met benchmark or 0 for those that have not met. Note: The report pulls assessment data from Infinite Campus State Edition. Until KDE loads the scores, the report will show a 0.

Aggregate Report:

- This report only counts graduates. If the count is too low, consult the detail report to verify graduation status and dates have been posted.
- Share aggregated PDF with school and district leadership for awareness and additional quality assurance.
- Use the aggregate report to help validate data for School Report Card reporting.
- English Learners during High School are included in the counts for All Students. These students qualify as Transition Ready after attaining English Language Proficiency in addition to Academic Ready or Career Ready.
