<u>Title III Immigrant</u> – The purpose of this report is to produce aggregated immigrant student data and the supporting student level detail for quality assurance review. This report is intended for internal use only, these reports contain sensitive data and must be handled appropriately.

<u>Selection Criteria</u>: A date range can be entered on the report landing page; if no date range is entered, the report will generate based on the Year selection in the toolbar. This report can only be generated in the current year or the three previous years. Use the Campus toolbar to select the school or all schools to obtain a district level report. Choose detail report for student level data to review data quality issues highlighted within the *Error Message* column. Choose aggregate report for an overview of the entire school or district. Check the Individual Aggregates with All Schools to generate an aggregate report for each school in the district.

The report landing page allows user to generate the output of the data based on a range of time by entering a start and end date. To obtain data on a specific date, enter the start and end date as the same day, such as, October 1. When a specific date is entered, the error message output will be based on the date entered on the landing page. If no dates are entered on the landing page, the data output would be based on the year selection in the toolbar.

- Review data quality issues highlighted and update data appropriately:
  - o Error Message: Date Entered US School > 3 Years Immigrant indicator on enrollment must be deselected
  - o Error Message: Date Entered US School Missing Enter correct date via Census | People | Demographics tab
- Share aggregate report with district and school leadership for awareness and additional quality assurance.
