Subject: KSIS Notification: 2022 Transition Data Collection Reminder

KSIS Points of Contact: Please see messages below from the Office of Career and Technical Education. Please help us ensure those working with transition data in your schools are aware of the due date and change in collection requirements. THANK YOU!

I'm reaching out to give a gentle reminder that the transition data in Infinite Campus (on the Graduation tab) for cohort 2022 graduates is due by **February 1**<sup>st</sup>, **2023**.

Please remember that for this cohort (and all cohorts moving forward) schools/districts are not necessarily required to collect data on all graduates (<u>please see my previous email below for a reminder explaining how we are partnering with KYSTATS to collect some of the transition data</u>). Schools/districts are only required to collect data on graduates that cannot be collected by KYSTATS. This includes all of the following graduates:

- o those that plan to enroll in college outside of Kentucky;
- o those that plan to enter into military/community/Peace Corps service;
- o those that plan to enroll in a proprietary technical school;
- o those that are continuing high school education (Grade 14 students);
- o and those students from the cohort that are deceased.

Having said that, if your school/district still wishes to collect data for ALL 2022 graduates you have every right to do so. However, if the data collected for a particular graduate does not align with what KYSTATS finds, then the KYSTATS data found for that graduate will trump the self-reported data. For example, imagine you mark in Infinite Campus that student A is attending college in Kentucky ("College – in KY" is option 1 in the dropdown list on the Graduation tab in Infinite Campus). However, imagine that KYSTATS does not find student A in the college-going files provided by the Council on Postsecondary Education (CPE) as officially attending college in Kentucky. However, KYSTATS does find student A in the unemployment insurance (UI) files as an employed person in Kentucky. The KYSTATS data will trump your self-reported data and student A will be marked as "Employed" as opposed to "College – in KY" for reporting purposes (in the KY School Report Card, etc.).

I hope that this all makes sense. If not, please reach out and I'd be happy to discuss further with you. Thank you in advance for your attention to this matter.

Good afternoon! We have a bit of exciting news. We have a plan to work with KYSTATS to collect data on the following graduates (starting with cohort 2020):

- o those that have enrolled in college in Kentucky;
- o those that enter directly into the workforce;
- o or a combination thereof.

What that means for your schools is that they only need to populate the "Transition Status" dropdown in the Graduation tab in Infinite Campus for those students that don't fall into one of those three groups (that cannot be collected by KYSTATS). In other words, starting with cohort 2020, schools will only need to follow up and populate the "Transition Status" dropdown in IC for the following graduates:

- o those that plan to enroll in college outside of Kentucky;
- o those that plan to enter into military/community/Peace Corps service;
- o those that plan to enroll in a proprietary technical school;
- o those that are continuing high school education (Grade 14 students);
- o and those students from the cohort that are deceased.

Further, I wanted to make you aware of a new role in Person Role Manager – Transition to Adult Life Contact. If your district has not yet assigned this role, you may want your WAAPOC to do so at his/her earliest convenience. In the future, all communications regarding transition will be sent primarily to this role list.

I hope that this information is helpful moving forward. If you have further questions I will be happy to assist. Thanks everyone, I hope all is well during this uncertain time.
