School Report Card (SRC) dates extended

The district review period is being extended to Friday, Nov. 22, to provide additional time for schools and districts to complete their data review. Schools are still asked to complete the Collection - Submit Collection Data by Nov 8. KDE will begin following up with districts that have not completed the Collection data entry and Approvals in early November. Public release of the new School Report Card dashboard is expected in early December.

Career and technical education (CTE) data is available in the School Report Card (SRC) Suite Collection and Approval Portal, for school and district review. The data being released is consistent with what has been reported in prior years, but the CTE data is being consolidated into its own domain. Schools and districts are asked to review this data in the Preview tool and raise flags if any issues are found. Please include comments when submitting flags to help the Kentucky Department of Education (KDE) investigate your concern. Schools that expect to see an update to their Career Pathways accountability data will see these updates reflected by the end of the week in the Preview view.

School Accountability and Academic Performance data and prior year (2021-2022 and 2022-2023) data that is already final will be available prior to public release. Additional charts and trend views will also be available prior to public release. While there is not an approval requirement for assessment and accountability data or the new views we do want to provide time for review. The current School Report Card Suite dashboard tool will sunset in December, there is limited time to compare data previously reported in the dashboard view to the new School Report Card dashboard data.

The issue with the superintendent message has been resolved and most of the messages have been restored. If your district is not seeing a previously entered message, please submit an <u>AnLar Helpdesk email</u> or the message can be reentered. If a school is having issues with data entered into collection items not copying over correctly to the School Profile Report download or other domains of the School Report Card, please contact the <u>AnLar Helpdesk</u>. The monitor flags and monitor approvals tool will be available by Thursday.

Recorded training and other resources are available on the SRC Resource webpage.

District Assessment Coordinators (DACs) and School Report Card Contacts:

Schools and districts should continue to review, raise flags and approve all open domains. The Overview, CTE, Education Opportunity, Transition to Adult Life and School Safety domains are open. Schools and districts can monitor outstanding flags in the reviewed flags report. Flags can be lowered as issues are resolved. The Kentucky Department of Education (KDE) will add responses that can be seen through that tool and lower flags if the response resolves. Districts can see responses by selecting both the "Lowered" and "Raised" filters in the flag statuses dropdown list. If there are additional questions regarding an item after a flag has been lowered, email the KDE responder directly.

Issues with the views, functionality of the system or questions about the training or Quick Reference Guides on the SRC Resource webpage should be reported to the <u>AnLar help desk</u>. There are a few known issues that are being addressed, no need to flag these issues.

- Teacher Turnover districts with overlapping annual calendars were not showing teacher turnover; data will be rerun and updated for all districts.
- Teacher Certification Data will be updated so the entire number can be seen.
- Teacher Working Conditions data is being updated and will be available soon.

- Aggregation of ineffective teachers' equity calculations to district level are not available. The
 calculation will aggregate data entered by schools in the collection tool to calculate district
 values.
- Data tables for Students with Disabilities are not showing in the Overview Student Subgroup Domain.
