## School Report Card Suite – Final Reminders and Sharing Requirements

Thanks to all school and district staff who contributed to the deployment of the <u>2023-2024 Kentucky</u> School Report Card (SRC) Suite Dashboard site.

The <u>SRC Preview Site</u> has reopened for schools that need to add or revise previously entered collection data. <u>Collection data</u> is entered and updated through the <u>Submit Collection Data</u> tool. Updates must be made by Jan. 21. At that point, the tool will close and all data will be final for 2023-2024 reporting.

Please remember, as a final step, to ensure local SRC sharing requirements are met. Districts must:

- Post SRC links to school and district webpages (all previously posted URLs need to be updated to link to the new school or district SRC).
- Share the SRC link with parents; and
- Publish a link in the newspaper with the largest circulation in the county.

AnLar continues to work on accessibility, mobile-ready and other SRC Suite Dashboard features. Districts and schools are welcome to provide general feedback on the new School Report Card through the <u>feedback tool</u> located in the "Help/Contact Us" section of the SRC Suite Dashboard site. The feedback will be shared with AnLar to help drive improvements to the new SRC Suite Dashboard site.

## Outstanding SRC data notes:

- Datasets are not yet available in the School Report Card Suite Dashboard site, 2023-2024
  Assessment and Accountability and prior year SRC datasets are available in the <u>SRC Suite</u>
  <u>historical dataset site</u> in Open House. All 2023-2024 SRC datasets should be available by Jan. 31
  within the SRC Suite Dashboard site.
- Overview/Faculty, Staff and Community/Equity
  - Students Taught by Inexperienced Teachers: Counts may be higher than in prior years because all teachers with less than 3 years' experience are counted; previously those without EPSB ID numbers in Infinite Campus were not included in match. Also note, if an inexperienced teacher has large class sizes or has all students on their class rosters (i.e., physical education teacher), the percentage of students taught by inexperienced teachers will be high.
  - Ineffective Teachers: District numbers are being adjusted to reflect only schools that reported data. Many schools did not report ineffective teacher data in the Collection tool and that caused an issue with district aggregations. The Collection tool is now open for schools to add or update data; if there are no ineffective teachers in a school, zeros should be entered. For schools that do not enter data, a default message will indicate that the school did not report data.
- Districts can continue to report data issues directly to the KDE data point of contact as indicated in the <u>Quality Assurance Worksheet</u>. AnLar has opened the SRC Approval and Collector tool for final updates through Jan. 21. This is the final opportunity for districts to enter or update data.
- 2023-2024 Financial Transparency data is not yet available in the new SRC Suite Dashboard site. Datasets are available for prior years, but the Kentucky Department of Education (KDE) is working with AnLar on re-creation of this domain with an expected release of May 2025 for 2023-2024 data.
