Private School Reservations by Program for School Year 2023-24

This report satisfies the requirement under Sections 1117(a)(4)(C) and 8501(a)(4)(C) of the Every Student Succeeds Act (ESSA). Each state's department of education is required to provide notice, in a timely manner to appropriate private school officials, of the allocation of funds for educational services and other benefits under covered ESSA programs that districts have determined are available for services. This report includes those amounts and some frequently asked questions and responses.

Frequently Asked Questions

- 1. Are these funds allocated directly to private schools? No. These funds are reservations districts are required to make and use for private school services such as student instruction, professional learning for teachers, and parent and family engagement activities.
- 2. How are services distributed to private schools? Generally, the amount of services to be provided is equitably based on factors such as student enrollment, students' low-income status, and student eligibility under the program for which services are provided. The method for calculating an amount for an individual private school varies by program. The amounts reported are the totals each district was required to reserve by program. Services are equitably distributed to private schools eligible for and electing to participate.
