The two areas for math will be (1) to use Number Talks as a way to incorporate higher yield thinking strategies and (2) hands on manipulatives to support the JCPS instructional curriculum maps. The two areas for reading will be to (1) develop the knowledge/understanding for implementing guided reading plans for students with appropriate leveled readers K-5 and (2) develop a school-wide writing program with the Lucy Calkins writing plan. A monitoring system has been developed by targeting one day a month to coach progress, new professional development and discuss instructional strategies for high yield products.


