Orton Gillingham strategies focus on teaching students with learning disabilities; specifically teaching students with Dyslexia. While Orton Gillingham strategies are effective, Byck Elementary does not have any students that struggle with dyslexia. Further, Byck Elementary needs focus on Tier I instruction and building capacity within the teachers at the school. In order to build capacity with teachers, our Resource Teacher and Goal Clarity Coach need additional strategies when working with teachers and teacher teams.</p> <p>Byck Elementary is requesting the redirection of funds in the amount of \$200 for mileage from MUNIS Code 2432053 0580 460B (Travel) to MUNIS Code 2432053 0581 460B (Travel Mileage).</p> <p>The institute will address the learning and implementing of key skills and coaching conversations to develop high functioning teams. The institute supports work with individual school educators in the building, as well as PLCs. The trainings will also help support coaches with priority standards 3.3a and 3.4b.</p> <p>As Dr. Kolodey takes new leadership at Byck Elementary and desires to build the instructional</p>

This will support our Improvement Priorities # 3.3a and 3.4b and get us off to the best start possible this school year to build the core instruction in our classrooms we so desperately need.
