## Final FY2025 Title V, Part B Allocations

- Final Title V, Part B allocations will be uploaded into the Grant Management Application and Planning (GMAP) system along with other allocations.
  - Final allocations are not uploaded until the original Consolidated Application has been approved by KDE.
- Different than previous years.
- If the district's Title V allocation amount changes, the GMAP application will require revision.
  - Budget page must be updated.
  - Program and Personnel Details pages may need to be updated.



# Title V and the Comprehensive Improvement Planning Timeline

- We are currently in Phase Four of the <u>Comprehensive Improvement</u> <u>Planning timeline</u>.
  - English learner (EL) plan for districts (Lau Plan)
  - Professional development plans for districts and schools
  - Progress monitoring
- Progress towards meeting goals outlined in the Comprehensive District Improvement Plan (CDIP) and Comprehensive School Improvement Plans (CSIPs) is monitored throughout the year.
  - Changes in identified needs or the use of Title V funds to address those needs may require changes to the GMAP application.



### **Master Eligibility Spreadsheet**

- RLIS Master Eligibility Spreadsheet Information
- The U.S. Department of Education (USED) releases the RLIS Master Eligibility Spreadsheet around February or March each year.
  - Most current spreadsheet: Federal Fiscal Year 2024 (used to determine school year 2024-25 eligibility)
- Used to determine which districts are eligible for the Small, Rural School Achievement (SRSA) and RLIS grants.
- KDE sends the spreadsheet to districts along with instructions for reviewing and verifying the data.



### **Understanding SAIPE Data**

- SRSA and RLIS eligibility is based on the district's poverty percentage as determined by Small Area Income Poverty Estimate (SAIPE) data.
  - At least 20% of the children served by the district must come from families with incomes below the poverty line and be located in a rural area.
- Districts can fall out of eligibility from year to year due to changes in SAIPE data.
  - Free and Reduced-Priced Lunch (FRPL) data is different from SAIPE data.

#### Differences Between FRPL and SAIPE

- Different income thresholds and different income levels for eligibility.
- SAIPE data is estimates based on statistical models, not direct counts.
- SAIPE poverty percentages cannot be duplicated or predicted using data available to districts or KDE.
- Best practice: Work with Title I, Part A to monitor tentative and final Census poverty percentages.
  - Notification of Tentative Census Poverty Percentages



# Best Practice for Coordinating your District's Title V Program: Consider Other Title Programs

- Title V is intended to provide additional funding for the other title programs
  - Title I, Part A including Parent and Family Engagement
  - Title II, Part A
  - Title III
  - Title IV, Part A
- If the district is no longer eligible for Title V funds, could some of the services and activities be shifted to other programs?



# District Needs not Currently Supported with Other Title Funds

- Non-Title I schools or schools/activities not served by Title I funds
  - High schools
  - Alternative education programs
  - Preschools
  - Summer school
- Activities allowable under Title III to support EL students
  - Must be supplemental to the core EL program outlined in the district's Lau Plan.
