Alternate Assessment 1% Participation: Updates, Results, Guidance and Trainings

Overview/Background:

- ▶ The Every Student Succeeds Act (ESSA) requires states to ensure that the total number of students assessed in each subject, using an Alternate Assessment does not exceed 1.0%. States who anticipate they will exceed 1.0% in alternate assessment participation must submit a waiver request to the U.S. Department of Education (USED).
- ▶ Kentucky requested a waiver extension on August 6, 2019 for school year 2019-2020. The waiver is available on the Kentucky Alternate Assessment Participation Waiver page of the KDE website.

District Requirements:

- Waiver submissions require KDE to provide <u>District Assurances</u> that the district is following the State's guidelines for participation in the AA-AAAS and will address any disproportionality identified.
- ▶ 142 districts exceeded 1.0% participation in alternate assessments for school year 2017-2018.
- ESSA requires each district to submit an annual justification if the district alternate assessment participation rates are greater than 1.0% in one or more subject areas. Justifications include factors that may have contributed to the district exceeding 1.0% participation. The <u>Local District Justifications for Alternate Assessment Participation Summary</u> of the responses is available on the KDE website.
- Districts exceeding 1.0% participation in at least one subject for 2018-2019 school year will be required to submit an updated justification. Data will be available in late fall 2019.
