## WHO IS AN ENGLISH LEARNER?

- English learners (ELs) are students aged 3-21 whose primary language is a language other than English [ESSA 8101(20)].
- Kentucky's ELs represent families who speak over 144 different languages.

### WHO IS A STUDENT WITH A DISABILITY?

A child evaluated in accordance with **707 KAR 1:300**, as meeting the criteria listed in the definitions in this section for autism, deaf-blindness, developmental delay, emotional-behavior disability, hearing impairment, mental disability, multiple disabilities, orthopedic impairment, other health impairment, specific learning disability, speech or language impairment, traumatic brain injury or visual impairment which has an adverse effect on the child's educational performance and who, as a result, needs special education and related services.





# STATEWIDE INCREASE IN ENGLISH LEARNER STUDENTS WITH DISABILITIES (ELSWD) 2012-2022

Statewide data indicates the majority of ELs with disabilities are identified under the Specific Learning Disability category. Other leading categories include Speech or Language Impairment, Developmental Delay, Mild Mental Disability and Autism.

### Statewide ELSWD by Disability Category



Since 2012, 38 of Kentucky's districts have experienced an increase of ELSWD by at least 2% or more.


# REGIONAL SPECIAL EDUCATION COOPERATIVES 2012-2022
