This data report is from the second public comment survey on the mathematics assessment blueprint. The survey was open for public comment in August – September 2019. During that time, the ARCC at ICF served as the third-party entity to solicit public comments. The ARCC is responsible for analyzing and summarizing the data for KDE and the Commissioner of Education. A total of 115 respondents began the survey, and approximately 40% (~46) completed it.
