WHEREAS, in Executive Order 2019-500, the prior administration reorganized the School Curriculum, Assessment and Accountability Council, abolishing the Council as created in KRS 158.6452; and

WHEREAS, in accordance with Executive Order 2019-500, the prior administration reconstituted the Council with a reduced membership, without receiving any of the recommendations required by KRS 158.6452, and appointed members completely lacking in racial or political diversity; and

WHEREAS, the General Assembly declined to codify or otherwise confirm the reorganization of the School Curriculum, Assessment and Accountability Council during the 2020 Regular Session, and therefore the Council reverted back to its statutory structure ninety (90) days after the General Assembly adjourned sine die; and

WHEREAS, in compliance with the governing statute, recommendations for all relevant positions on the Council have now been received:

NOW, THEREFORE, I, ANDY BESHEAR, Governor of the Commonwealth of Kentucky, by virtue of the authority vested in me by KRS 158.6452, do hereby appoint the following as members of the School Curriculum, Assessment and Accountability Council:

Allison Tamme, Danville, representing parents, to serve for a term expiring October 5, 2023;

Leslie Jeffries, Canmer, representing parents, to serve for a term expiring October 5, 2025;
